These policies, according to the workers' union, include the recent hike in price of Premium Motor Spirit (PMS), otherwise known as petrol, increase in Tinubu asks for more time

public school fees, as well as the non-release of eight months withheld salary of university lecturers and workers and increase in Value Added Tax

Already it has called on its affiliate unions to kick off mobilization of their members for the industrial action, which it said, pauperized Nigerians had pressured the body to

commence, given FG's alleged indifference to the outcry of downtrodden Nigerians over its hurtful policies.

Finland-based Simon Ekpa, a self-acclaimed disciple of detained leader of Indigenous People of Biafra (IPOB), Nnamdi Kanu.

Senate heard a motion which sought the release of Kanu but declined a bid to urge the Federal Government to use political solution to free Kanu, who is being prosecuted for alleged terrorism.

No student should pay tuition in federal varsities -FG

ith tension rising in sone higher institutions across the country over increase in fees, the Presidency yesterday cleared the air on the matter.

It will come as sweet music to the ears of many students and some parents/guardians that the Presidency has debunked media reports (not in Daily Times) that the Federal Government (FG) has increased tuition fees in federal universities in the country.

More tears, again, as FCTA demolishes over 5,000 unapproved buildings

t was another chapter of tears and sorrow as earth-moving equipment of the Federal Capital Territory Administration (FCTA) pulled down over 5000 buildings, deemed illegal, in the densely populated Gishiri community, an extension of Katampe District in the nation's capital, yesterday.

The development was part of efforts to enforce strict adherence to the Abuja Masterplan, the document spelling out developmental stipulations in FCT. The hurricane of demolition had swept across several other areas in FCT in the past

couple of weeks. One of the affected areas is Trademore Estate, Lugbe, where many buildings, said to have been erected on waterways, were brought down. The matter eventually ended up in court with the FCTA authorities being restrained from carrying out further demolitions in the popular estate even as the matter is still in court.

Also demolished in Gishiri were unapproved buildings in a green area, which is in hectares of land space, around the foot of the Katampe hill, designated and reserved for development of a multipurpose recreational facility, as well as makeshift structures built along road corridors in the area.

Speaking yesterday during yet another round of removal, the District Monitor in charge of Katampe and Mabushi for the Department of Development Control, an organ of FCTA, Samson Atureta, said the enforcement (demolition) team

Fuel price hike, hardship: NLC to embark on nationwide protests Aug 2, hands FG 7-day ultimatum

after rising from its Central Working Committee (CWC) meeting and signed by NLC President, Joe Ajaero, the Congress issued a sevenday ultimatum to FG to address all the demands or be ready to watch workers take to the streets nationwide in protest.

Top of their sevenpoint resolutions were the immediate reversal of all anti-poor policies such as the recent hike in PMS price, Increase in public school fees, and others.

NLC demanded: "The immediate inauguration of the Presidential Steering Committee as agreed in the earlier consequential dialogues.

'To begin the building across the nation of a coalition of all Nigerians where all will be leaders and all will be followers.

"To call on all civil society organisations and Nigerians wherever they may be to begin mobilization to take action on their own to save our nation.

"To lead and organize mass protest rallies across the nation to demonstrate outrage against the inhuman actions and policies of the government.

"To give the Federal Government a seven -day ultimatum within which to meet all our demands and to embark on a nationwide action beginning Wednesday the 2nd of August, 2023 to compel the government to reverse its anti-poor and anti-workers policies.

consequently "To direct all affiliates and state councils to begin immediate mobilization and closely work with associations, individuals and other entities including the ones already on the streets to ensure that government listens to the people."

The CWC-in-Session said that the resolution

reached exhaustively deliberating on the crippling economic situation facing Nigerians its attendant consequences of mass suffering, poverty and angst pervading Nigerian workers and peoples which are clear resultants of the insensitive policies and actions of the present Administration.

The CWC-in-Session recalled that on May 29, the President Bola Tinubu gave Nigerians an inaugural speech prompted the immediate increase in the price of Premium Motor Spirit (PMS) from N185 to N500; as action which was considered and strongly condemned by various Organs of Congress because of the massive suffering it imposed on the lives of Nigerians.

"As if that was not enough, the federal government through the instrumentality of the NNPCL effected a further hike in the price of PMS to N617 per litre without having addressed the dire consequences which the earlier hike had imposed on Nigerians. Other anti-poor policies have since been unleashed on Nigerians which have left workers and masses reeling and deeply impoverished.

"CWC-in-Session noted unfortunately: That the Federal Government has shown enormous disdain and contempt for Nigerian people and workers having acted and continued to act without regards to the welfare and cries of the citizenry.

Government 'That seems to have declared a war of attrition on Nigerian workers and masses without any care leaving them to the throes hopelessness and helplessness.

That the Federal Government has refused to put in place safeguards to protect Nigerians from the

harsh economic situation that its policies have inflicted on the people; rather it has decided to insult the sensibilities of Nigerian masses by offering us N8,000 per family and offering themselves N70billion.

"That the Federal Government has frustrated and abandoned its own Committee which was a product of social dialogue between the government and workers' organizations in the country. While the Committee has not met, the government embarked on unilateral actions and

programmes. "That s since President's "subsidy is gone forever" speech at Inauguration Day; the peace of mind of Nigerians has gone; decent living gone increasing despair of unimaginable dimensions.

"That the Federal Government has continued to treat Nigerians as slaves and conquered people, which it treats with impunity without any concern on the consequences.

"That the Federal Government has continued in an unholy mission of robbing the poor to pay the rich in Nigeria as typified by its continued frustration of the activation of the agreed alternatives to Premium Motor Spirit (PMS) and new hike in prices of PMS to N617 per

"That the Federal Government has continued to promote the gang-up of the ruling elite against Nigerian people and workers.

"Observes that the Federal Government has continued to churn out without relenting policies designed to emasculate Nigerian workers and people via not just increases in PMS prices with its spiraling affect but also increases in VAT, increases in school fees across all publicly-owned secondary and tertiary institutions of learning.

That the NNPCL has turned itself into the forces of demand and supply and fixes the price of petroleum products while mouthing deregulation.

That Government's conduct suggests it does $not\ intend\ to\ commit\ itself$ to the MoU it signed with NLC and TUC."

Sequel to this, the CWC-in-Session said that Nigerians are outraged and have been putting pressure on NLC to lead them in protest against the increases in the pump price

While noting that the pressure has come to a breaking point and given Government's continued indifference to the plight of the poor, the Congress resolved that it would not be party to the killing of poor Nigerian workers and masses.

The CWC-in-Session also said that it is the responsibility of men and women of conscience propelled by patriotic zeal to take necessary action to "protect democracv and our beloved nation since it is clear that the Federal Government is not interested in discussions having exhausted half of the agreed 8 weeks without activating the Presidential Steering Committee".

Meanwhile, as labour warmed up for the industrial action, President Bola Tinubu, yesterday, appealed to them to give him more time to adequately address their demands.

The appeal follows the bid by both NLC and the National Association of Resident Doctors (NARD) to commence strike.

Special Adviser to the President on Energy, Olu Verheijen, met with NLC and Trade Union Congress (TUC) leaders at the Presidential Villa in continuation of talks on palliatives to cushion the effects of subsidy removal.

The steering committee, which met briefly, focused on how stakeholders can fast-track interventions that will bring relief, particularly around Compressed Natural Gas (CNG), mass transportation, cleaner energy, transportation, and reducing the impact of the cost of transportation on the citizenry.

NLC President, Ajaero, while responding to questions from newsmen, insisted that organized labour would definitely stage a protest on August 2.

Speaking on the outcome of the meeting, he said: "Well, the outcome is very brief. We met based on N520 increase and the committee that was set based on that that and we agreed to work to realize the objectives that was set during that moment.

Asked why the interventions was getting delayed, when Nigerians are facing excruciating pains, he said: "The two centers (NLC and TUC) have made their position known and is before Nigerians; the TUC, the NLC, our position is known. And it's public knowledge."

Also asked how feasible the proposed industrial action was, he said: "I wouldn't know, we are going ahead with the protest because we have to be emphatic on what we put in our communique, to say we're commencing protests from the August 2".

Also speaking to State House correspondents in Abuja, after leading members of his leadership to brief President Tinubu on the outcome of their engagement with the National Association of Resident Doctors (NARD), Speaker of the House of Representatives, Tajudeen Abbas, said that President Tinubu has pleaded that since he is new in office, he needs time to evaluate the issues that are being raised by workers over which he is yet to be briefed.

The Speaker said: "What he said is that he's just coming on board. We should ask them and beg them to please give him a little more time. The things that they mentioned, he is completely unaware of them, he is yet to be briefed about all those issues.

"But from what he heard from me, also advised that we should channel those issues to the Chief of Staff to look at them one after the


"I believe the next coming days, some concerted actions will be taken."

He said the House leadership invited NARD following their intention to go on strike, saying that the lawmakers succeeded in persuading the union to shelve the plan.

"Sequel to the meeting we had with them, there were series of conditions that they gave, that we felt we need to share with the president," he said.

According to him, the purpose of the visit to the Presidential Villa late Wednesday was to intimate the President on the progress made with the doctors' association.

He also disclosed that the House leadership also used the visit for familiarity purposes as they had not met with the president since

The Senate decision was sequel to a motion 'Condemning the Disruptive Nature of 'Sit-At-Home' Demonstrations in the South East-Nigeria' sponsored by Senator Osita Izunaso (Imo West).

motion Izunaso's was co-sponsored by all senators from the South East irrespective of political party affiliation.

They are Senators Orji Kalu (Abia North); Abaribe, Enyinnaya (Abia Umeh, South);Victor Central); (Anambra Darlington Nwokocha (Abia Central),;and Nwebonyi Peter (Ebonyi North). Others are Ifeanyi Ubah (Anambra South); David Umahi (Ebonyi South): Ndubueze Patrick Chinwuba (Imo North); Nwoye Tony (Anambra North); Kenneth Emeka (Ebonyi Central); Okechukwu Ezea (Enugu North); Onyewuchi Francis (Imo East); Osita Ngwu (Enugu West); and Chukwu Kelvin (Enugu East).

Izunaso said: "Thousands of innocent lives have been lost since this action started, and properties worth over a Trillion have been destroyed which has resulted in investors leaving the region.

"Further aware that the sit-at-home civil disobedience actions in the South East have led to the disruption/destruction of economic activities as well as immeasurable financial losses for businesses, workers, and the local economy. Because, when people are forced to stay at home and businesses remain closed, productivity declines, and income is reduced, thereby affecting livelihoods and economic growth.

He noted that the sitat-home protests disrupt the education of students. leading to missed classes and delays in academic progress, adding that such

prolonged disruptions have long-term effects on students' learning outcomes and educational development.

The motion further said: "Disturbed that disruption of essential public services, such as healthcare, transportation, and waste disposal, continues to have severe impact during 'sit-at-home' protests which adversely affect the well- being and safety of the general population living in the South East; Further disturbed that the 'sit-at-home' protests continues to lead to acts of violence and clashes with law enforcement agencies which has led to uncountable loss of lives of innocent people, security agents and the protesters as this increases the potential for criminal elements to take advantage of the situation to engage in looting or other unlawful activities while the people stayed at home.

"Worried that if the activities of Simon Ekpa, who is issuing the Illegal 'sit-at-home' orders is not checked, he may succeed in corrupting the minds of Nigerian youths and turning them against the government which is tantamount to treasonable felony", Senate condemned his actions and manipulations and asked the executive arm to do as resolved.

It would be recalled that in August 2021, IPOB declared a sit-at-home order every Monday in the zone over the continued detention of Kanu and demanded his release.

However, but the proscribed body eventually called off the directive after about three weeks of the declaration.

However, Ekpa continued to enforce the directive in the zone, resulting in public spat between him and IPOB leaders who insisted that Kanu had directed its suspension.

Bayelsa govt reunites two-month-old baby with mother

ayelsa State government yesterday reunited a twomonth-old baby, Success, rescued from suspected child thieves at Azikoro community last month to the legitimate mother, Joy Lucky, after spending one month at Gloryland Orphanage, Opolo.

A Magistrate Court sitting in Yenagoa had earlier this month ordered the remand of a 30-year-old man, Kingsley Solomon, at the Nigeria Correctional Centre, Okaka, for allegedly stealing the baby.

Solomon, who was arraigned by the Bayelsa State Police Command before Magistrate Sarah B. I. Avoh on two counts bordering on assault and child stealing, had claimed that he was the legitimate father of the child, when he forcibly collected the child from the mother and made away with the baby to an unknown destination.

But respite came the way of baby and mother when a top official of Eunice Nnachi Women Advocacy Foundation (ENWAF) met the suspect with a child and invited the Azikoro Police division to investigate the circumstances surrounding the handling of a two-month-old baby by a man who is not capable to take care of a child.

Bayelsa State Commissioner for Women, Children Affairs and Social Development, Mrs. Faith Opene, who returned the child to the mother, commended ENWAF for partnering with the ministry in catering for the welfare of women and children in the state.

She advised young girls in the state to embrace knowledge through education or skills acquisition in order to fi-



nancially empower themselves before they start to produce children.

Opene urged mothers to take proper care of their children in order to have a better society.

She said: "Young girls should take their education seriously, learn a trade or get skills that would make their lives meaningful."

Founder of ENWAF, Lady Eunice Nnachi, expressed happiness over the safe return of the child to the mother, urging parents to be responsible in training their children.

Suspected internet fraudsters kill landlord in Delta

uspected internet fraudsters, popularly called 'Yahoo Boys', allegedly murdered a man in his 20s in his compound located along Ugbo Road, Okpaka community, Udu Local Government Area of Delta State.

The deceased, who was popularly called 'Young Landland', was allegedly stabbed multiple times in his chest and stomach before he gave up the ghost, in the early hours of Monday in his sitting room.

It was unclear what his

relationship with the suspects was or why they had to murder him.

The deceased, who is the owner of the building where the unfortunate incident occurred, had three tenants as occupants.

One of the tenants, who spoke, said that he did not hear any sound from his landlord's apartment due to the fact that his electricity generating set was on till the early hours of the next day due to outage from public power supply.

He noted that during the day, the deceased usually had a lot of people visit him on regular basis due to "his simplicity as a person and was mostly loved by all."

The deceased hailed from Okpaka community and is survived by his wife, a child, siblings, relatives and aged parents.

His remains were later deposited at a mortuary yesterday by his relations.

This incident came barely a year after suspected Internet fraudsters 'Yahoo boys' shot dead another of their colleague, Mr. Ovie Efe in his compound, in Ugbo Road, Okpaka community, around 3:00 pm on that fateful day.

Police Public Relations Officer in Delta State, Bright Edafe, confirmed the incident, adding that Investigation was ongoing.

followed due procedure and got necessary approvals for removal of the encroaching structures

Atureta said the team was in Gishiri to continue the removal of encroachments in the area, saying the exercise has been ongoing in parts of FCT and targeted at reclaiming plots for legal allottees.

According to him, people who have the right allocations to the plots could not take possession because, overtime, some people were dividing and selling parts of the plots under the guise that such were 'local or indigenes' land', with unsuspecting persons buying and subsequently developing the plots.

The official explained further: "Those are the houses we have continued to remove today so that the rightful allottees will take over their plots. And you could see that there are some new perimeter fences coming up, and they are being erected by the rightful allottees.

"We needed to follow due procedures, and that's why we are here after we got approval to remove the encroachments. We have been doing it in bits; now we are about 60-70 per cent in the removal of the illegalities there

"And since we started, we must have removed at least 5,000 shanties or illegal developments in Gishiri."

The District Monitor added: "Also, people have

started building in a green area which is in hectares of land space, around the foot of the hill, which we are reclaiming, as the place is for

"So, we are reclaiming that for the developer of the recreational area to take possession of the place. It is a continuation of what we had started, so that we make Gishiri a serene place.

"We are reaching out to the rightful owners of the encroached plots that we can get in contact with. There are some that had submitted their building plans for approval, but we couldn't process them because there were indigenous persons there. In fact, some of them are the ones reaching out to us as they have complained over time about encroachment on their plots."

It was observed that regulatory Development Control Department officials, backed by a joint team of heavily armed security personnel, stormed the area with one bulldozer and two excavators and removed those structures bearing the department's for-demolition markings while structures with legal approval for development were left untouched.

Some occupants of the illegal structures were observed lamenting their fate as the earth-moving equipment rumbled up and down, bringing down the buildings and squashing virtually everything on their path.

HURIWA asks IGP to take over investigation into Anambra lady's death

ivil rights advocacy group, Human Rights Writers Association of Nigeria (HURIWA) yesterday tasked the acting Inspector General of Police (IGP), Kayode Egbetokun, to take over investigation and fish out perpetrators of the heinous killing of a young lady, Chinyere Awuda, found dead at the abandoned swimming pool of Cosmila Hotel in Awka, the Anambra State capital.

HURIWA, in a statement by its National Coordinator, Comrade Emmanuel Onwubiko, warned that the police must not sweep the case under the carpet because of the influence of mega monetary inducements from powerful people connected to the incident.

The group said it will be a subversion and subjugation of justice if the police failed to dispassionately carry out an independent forensic probe to unravel the mysterious killing of the young lady within the hotel oremises.

HURIWA said it has become imperative that the IGP transfers the investigation to specially set up forensic and crime investigators from his office so the Anambra State Police Command does not undermine the dispensation of justice.

The rights group said there are allegations that many police officers working in the Anambra State Police Command have been in the state for many years and were alleged to be surviving by sending financial inducements to top officers at Force Headquarters, Abuja, to extend their stay in

HURIWA claimed that the reason is that "it is being alleged that such alleged rogue officers engage in transactional deals with such controversial cases as the alleged lynching of the girl in the Awka based hotel."

The rights body said: "According to reports, the young lady was at Club Mila, a nightclub reportedly owned by Cosmila Hotels in Awka, where one Gabriel Chinemere and friends, believed to be clubbers as well, allegedly started beating and molesting her for reasons yet unknown.

"The deceased, who hailed from Nnobi in Idemili South Local Council of Anambra State, was reportedly found dead and her corpse dumped in the swimming pool.

"The molestation allegedly took place in the presence of the club's manager, one Steven Junior, who allegedly directed the club security guards and bouncers to stand down and turn off the lights, while the girl was being beaten and dragged outside the club.

"The family of the deceased reported the matter to the Anambra State Police Command when thev found their daughter dead in a swimming pool in the hotel. However, the police spokesman in the state, Tochukwu Ikenga, confirmed that some suspects were already in custody but failed to confirm their number and reveal their exact identity.

"The step by the Anambra State Government sealing off Cosmila Hotel, Awka, where Chinyere Awuda allegedly lost her life is a step in the right direction.

"However, beyond the sealing of the hotel, justice must be served on the matter. Governor Charles Chukwuma Soludo should be personally concerned about seeing to the logical action adopted by relevant law enforcement authority both at the Federal and state level.

HURIWA warned against delayed justice in the case.

It said: "Money should never be allowed to influence the ability of the police investigators to reach a verifiable and concrete determination of what led to her death. This is because the attempt to propagate a different tale from the

initial story of the cause of her death must never be allowed or else it will be seen that Nigeria Police Force has still not realized that life is sacred and inviolable.

"HURIWA asks the IGP to do everything within his power to demonstrate his competence and capacity to punish the offenders who should be found through scientific and forensic details to be generated by the investigators.

"Those who attended the party should be interviewed by the office of the IGP in camera so as to safeguard the confidentiality of their testimony. Justice must be

"In addition to the Students' Loans Scheme, under the Student Loans Bill signed into law by President Tinubu last month, which will go into implementation ahead of the next academic session in September, the Federal Government will also strengthen other mechanisms to support indigent students.

"Parts of the government's plans to make sure all diligent students complete their education on time, notwithstanding their parents' financial situation, include work-study, merit-based scholarships and grants," the statement said.








Tinubu's Masterstroke on drug addiction

choing with a bang from my office TV set right before me is this familiar British-styled narration of a certain investigative reporting by a reporter from Skynews cable television- one of the world's most credible news outlets.

The item of their journalis-tic focus as I put pen to paper today, was precisely the frantic search for what the British parliamentarians do with cash that drops in from their political donors.

This report is all about letting us know that Great Britain practices Open Government Partnership which highlights the imperative of public officials adhering to the tenets of transparency, accountability and full disclosure of information on how public money is spent.

Fantastic as the investiga-tive report sounded to me as a professional journalist, but as a Nigerian, I was actually focused on something else- a very terrible crime that happened not far away from where I was seated in Garki 2, Abuja, scribbling away this reflection in my office.

That seemingly unfatho-mable crime was a direct consequence of hard drug addiction by some three young students.

Well, as I thought deeply about why three university students could take away the precious life of another youth all because the three who were on hard drugs had no money to pay their victim for his services which he rendered to them as a cabman, I recollected that there is a nexus between this incident and the productive speech of deep thinking by President Ahmed Bola Tinubu few days back which I consider as a Masterstroke on how to tackle the effects of hard drugs addiction.

We will get to that soon.

Speaking about the President's Masterstroke on confronting hard drug addictions, takes me to recollecting the fact that this struggling young Bolt driver murdered by these three drug addicts, never knew he actually drove his customers to pick up some more hard drugs somewhere in Abuja which drove them into overdrive of insanely deciding on their unfortunate trajectory.

The President of Nigeria spoke about the need for effective rehabilitation of drug addicts and avoidance of stig-matization of these persons. Ironically, the University whereby these killers came from, spoke to the same issue of rehabilitation which we will very soon come to see as we progress.

However, to think that this dastardly criminal act occurred barely days after the President, Ahmed Bola Tinubu, made some scintillating but deep thinking statements on what the society should do to rehabilitate hard drug addicts, offers us the rare privilege of once more appreciating the urgency of taking concrete steps to roll out comprehensive drug rehabili-tation programmes and to give adequate funds to the National Drug Law Enforcement Agency (NDLEA) for this singular purpose. Luckily, Nigeria has a very active and patriotic head of the NDLEA at the moment in the person of Brigadier-General Mohammed Buba Marwa

As stated above, the President's speech at that event by the NDLEA was indeed a product of deep thinking. And on the issue of deep thinking, we recall that Daniel Kahneman, in his book, 'Thinking Fast and Slow', posits that we use two primary modes of thinking in order to process information and make decisions - System 1 and System 2.

System 1 is intuitive, unconscious, instant, automatic and emotional while System 2 is slow, rational, reasoning, conscious, reflective and deliberate.

Our active thoughts and actions vary depending on what mode is running. Slow, deliberate, logical and focused thinking is often used in solving complex problems. That type of thinking deliberate thinking is more reliable but we don't usually stop to reflect and make slow decisions because our responses are automatic.

Because of that, we need to hone our thinking skills. Let's go over

what exactly it takes to think deeply about complex problems; and the multiple levels of thought that are involved.

The author then went into some details on Shallow vs. Deliberate Thinkers and told us as follows: Most of our decisions in life are administe-red by our life experiences or the mental models we develop over the years (how we have been taught to think at home and at school). That is how we make sense of the world we live in.

The problem arises when we limit ourselves to just that thought process. That is what shallow thinkers do.

Shallow thinkers do not think beyond the immediate and the observable. They usually take information at face value and only look at immediate consequences.

They are not capable of looking at all sides of an issue or think deeply about the issue before making decisions or drawing conclusions – they solve a problem with one solution. And they typically believe they are right.

They also believe that their opinion is based on deep thinking because they genui-nely believe that their opinion is based on truth

Whereas, deep thinkers look at the whole sequence of events and the consequences, the author concluded.

And so on that deep thinking speech of the President we recall that he spoke at an event organized by the very vibrant NDLEA headed by Marwa who ironically handed over the baton of leadership of Lagos state to the man who is today the President of Nigeria at the time General Marwa was on his way out as military Administrator and he, Bola Ahmed Tinubu was coming in as the democratically elected governor of Lagos state.

Besides, this bloodletting by the three undergraduates happened in Abuja almost at the same time that in far away Port Harcourt, Rivers state, the Director General of National Youth Service Corps (NYSC) was warning youth Corpers

to absolutely say No to hard drugs. Already, the management of Bingham University has declared that it has zero tolerance for drugs and other vices on the institution's campus.

Director of Public Affairs of the University, Mr Daburi B. Misal articulated the position of the institution in a press release issued

"The attention of the Management of Bingham University has been drawn to a news report making the rounds on social media on 3 suspended students of the University being paraded by the authorities of the Abuja Police Command on the alleged killing of one Obasi Okeke, a Bolt driver, over a scuffle on transport fare of their trip to a destination in Abuja.

"The Management of the University hereby expresses its profound sadness over the development and states that the affected students were in March 2023 identified through the University's zero tolerance policy on drugs and suspended from the university for being in possession of Marijuana and other illicit substa-

"As required by our regulations, the students should have been taken to a rehabilitation centre by their guardians and would be taken back to the University only after certification by the University's psychiatrist. It was therefore shocking to see that students who were supposed to be in rehabilitation were being paraded by the Police in Abuja. While the University maintains zero tolerance for vices, the responsibility of bringing up children is a shared responsibility. The University will, however, continue to do its best to put them on the right path."

Also, the Director-General, NYSC, Brig.-Gen. Yusha'u Ahmed, at the weekend warned the 2023 Batch 'B' Stream One corps members to stay away from cultism and drug abuse, especially in the orientation

He stressed that anyone who violates the scheme's rules and regulations would be appropriately sanctioned.

Ahmed gave the warning on Friday in a nationwide address to the corps members, who recently began their orientation exercise across the

As aforementioned, President Tinubu had said his administration would work closely with the NDLEA and its international partners to fight the menace of drug abuse.

He urged stakeholders to take a people-centred approach to address drug addiction, saying addicts are also humans who deserve understanding and support to recover from the downward path of drug abuse.

"I want to assure everyone, including our local and international partners, of this administration's unwavering support for the sustenance of drug control efforts,' Tinubu said in his opening address at the national conference to mark this year's International Day Against Drug Abuse and Illicit Drug Trafficking, at the State House,

The President, who was represented by the Secretary to Government of the Federation, George Akume, said interventions to address drug use and its associated consequences must recognize the individual and address the social stigma that comes with the menace.

Speaking of persons struggling with drug abuse, the President said, "These groups often face barriers in accessing health care and social services within society to address their drug use problems.

"Therefore, interventions to address drug use and its associated consequences need to be mindful of the fundamental individual. Stigma, both social and structural, which is one of the commonest barriers to access support and services must be removed."

He urged stakeholders to educate themselves and others on the dangers of drug abuse and the need to stop stigma and discrimina-tion.

As we digest this President's Masterstroke on the handling of drug addicts, one important reminder to His Excellency Mr. President is to say that rehabilitation of drug addicts is highly capital-intensive just as the budgetary appropriation to the NDLEA is grossly insufficient to han-dle this arduous task, making it imperative that we advocate the granting of financial and operational autonomy to NDLEA.

I will conclude with just one example of how much it costs the government of the USA to rehabilitate drug addicts. For instance, around September 24th 2012, www. drugfysrehab.com quoted the popular Cable News Network's programme CNNMoney as releasing mind-boggling statistics to the effect that yearly, the cost of prescription drug abuse is about \$US70 billion. Approximately, \$US44 billion of the aforementioned amount is lost in productivity with another 4US8.2 billion only coming from justice costs. And addicts who shop around for doctors cost insurers 4US10,000 to \$US15,000 per person per vear.

Dear Mr. President, rehabilitating drug addicts is a billion dollar project just as I end this article by thanking you for your deep thinking as earlier specified and to conclude by urging you, your government, the private sector and the international funding partner organizations to do all within their financial wherewithal or rather power/might to support the efforts of NDLEA in rehabilitating drug addicts.

I'm one of those Nigerians who are waiting to applaud President Tinubu should the six drug rehabilitation centres by the NDLEA be completed and commissioned timeously by President Tinubu.

Nigerian universities and e-learning

more than one occasion, the National Universities Commission (NUC) has stated that Nigeria cannot $efficiently\, operate\, e\text{-learning}\, programmes$ in its universities due to lack of infrastructure, electricity supply and internet access. These shortcomings will require some time to address. Sadly, lack of infrastructure and electricity supply has been the bane of our existence in Nigeria for many decades now - with internet access joining the list more recently. These have affected not just e-learning but, every other sector, industry, and the general quality of life in Nigeria.

The entry of Coronavirus pandemic in Nigeria and the lockdown that followed in the first half of 2019 highlighted the critical need for an online alternative for almost every sector.

At the onset of the lockdown, even developed countries struggled to transit seamlessly to e-learning, and many developing countries could not. In Nigeria, the private education space adopted a pseudo solution for e-learning. However, majority of the learning population were left stranded. Even in private schools, the factors listed above made e-learning less efficient and more expensive than it should be.

The need for e-learning or online education was not only occasioned by the lockdown or inability of many schools to operate physically. E-learning is the future of formal education. For example, in a cosmopolitan university that cannot accommodate all students on campus, we often have students commuting to and from the campus from far-off places. Online classes should be an option to make learning for such students more convenient. It will also allow the schools to reach potential students across state and country lines. Currently, Nigeria has now less than 92 public universities and 79 private universities. Most of the public universities lack basic requirements for efficient learning. There are not enough computers, and most students cannot

afford laptops. Where there are available devices, an epileptic or absence of electricity supply means devices cannot be powered or used as needed. Additionally, battery life is always at risk with erratic charging and sometimes sub-optimal voltage. Alternate power supply is available but requires additional financial capacity. Internet data is still relatively expensive in Nigeria, and we do not have enough fibre network across the country (or even in states) to provide the seamless streaming required for online educational interaction. Given these challenges, the NUC needs a plan to address these issues for e-learning to be fully adopted. Currently, lecturers and students use personal resources to augment the almost non-existent infrastructure. These personalised solutions are not secure or properly coordinated. They are also costly. Some options to mitigate these infrastructure and cost challenges include the NUC or educational institutions entering partnerships with leading infrastructure providers to procure equipment in bulk and take advantage of economies of scale. Corporate bodies and multinationals can also devote some of their CSR budgets to enabling e-learning in tertiary institutions which act as a feeder into the pool from which they search for and recruit talent. Indeed a few companies in the Telecoms, Technology and Banking sectors have supported some universities by providing free Wi-Fi hotspots. These gestures are, however, merely drops in the ocean!

It is also pertinent to note that Infrastructure is just one aspect of the system. Another significant aspect is the content. To successfully implement and adopt e-learning, the content needs to be prepared in suitable e-formats and modules. Platforms for testing, recording, assignments also need to be created and populated. Yet another aspect which is probably the most critical is training and change management. Teachers that will deliver training via e-learning and the students who will interact via this mode need to embrace change.


Finally, the entire e-learning system must pass integrity and quality tests. This is crucial for our accreditations from an e-learning system to be viewed as credible anywhere in the world. Putting all of this in place requires planning, investment, and resources. This will take a bit of time but obviously should be prioritised over an acceptable timeframe as it is evident that the rest of the world is not waiting or slowing down. A point to note is that of sixteen countries with the best conditions for implementing e-learning in the world, ten were ranked as having the top education systems in general. Given this interesting correlation between the quality of education systems in a country and their ability to implement e-learning successfully, a disturbing question comes up. Is implementing e-learning in our universities akin to merely putting lipstick on a pig? Whatever it is, we cannot delay e-learning. The time for a thorough overhaul of our educational system is now!

Soldiers detain Niger president, Tinubu, world leaders condemn coup bid

resident Mohamed Bazoum of Niger Republic was being detained in the Presidential Palace in Niamey, the capital, by soldiers in circumstances neighbouring countries and world leaders condemned as an attempted coup.

Details of what led to President Bazoum's seizure and detention by his own guards remained sketchy as of press time.

The United Nations (UN), United States (US), European Union (EU), African Union (AU), ECOWAS yesterday denounced any attempt to seize power in Niger.

The Palace housing President Bazoum was still blocked by angry soldiers of the Presidential Guard at the time of filing this report and several ministries that were affected by the blockade remained locked as of press time.

The disgruntled soldiers sealed off access to the president's residence and offices. The soldiers also refused to release the president.

There were fears of a coup as the guards detained the president, but in city and suburbs normal businesses and activities were going on.

The army has reportedly given the renegade soldiers ultimatum just as the president's office tweeted that the guards unsuccessfully tried to get support from the military in their "anti-republican" efforts. Sources said talks were underway to ensure that it did not turn to a shoot-out between loyalists and renegades.

Reports say the immediate former president, Mohammed Issoufou, and other former presidents are currently involved in talks to stop the situation from escalating.

"The President of the Republic and his family are doing well. The Army and the National Guard are ready to attack" those involved in this incident, the president's office added.

The landlocked West African state has experienced four coups since independence from France in 1960, as well as numerous attempted coups.

President Bazoum, who was democratically elected in 2021, is a close ally of

The country's last coup occurred in February 2010, overturning then President Mamadou Tandja.

Niger is grappling with two jihadist campaigns one in the south-west, which swept in from neighbouring Mali in 2015, and the other in the south-east, involving jihadists based in north-eastern Nigeria.

Militant groups allied to

both al-Qaeda and Islamic State are active in the coun-

Two neighbouring countries, Mali and Burkina Faso, have experienced coups recently triggered by jihadist uprisings.

Nigeria, another neighbouring country, immediately condemned the action as unpleasant developments.

President Bola Tinubu swiftly reacted to the reports that some elements in the military were holding Bazoum captive.

President Tinubu, in a statement he personally signed as Chairman, ECOW-AS Authority of Heads of State and Government, unequivocally condemned the development.

The statement entitled 'Unpleasant developments in Niger Republic', read: "Information filtering in from the Republic of Niger indicates some unpleasant developments around the country's highest political leadership.

"It should be quite clear to all players in the Republic of Niger that the leadership of the ECOWAS Region and all lovers of democracy around the world will not tolerate any situation that incapacitates the democratically elected\ government of the country.

"The ECOWAS leadership will not accept any action that impedes the smooth functioning of legitimate authority in Niger or any part of West Africa.

"I wish to say that we are closely monitoring the situation and developments in Niger and we will do everything within our powers to ensure democracy is firmly planted, nurtured, well rooted and thrives in our region.

"I am in close consultation with other leaders in our region, and we shall protect our hard-earned democracy in line with the universally acceptable principle of constitutionalism.

"As the Chairperson of **ECOWAS Authority of Heads** of State and Government, I state without equivocation that Nigeria stands firmly with the elected government in Niger and equally conveys the absolute resolve of leaders in our sub-region that we shall not waiver or flinch on our stand to defend and preserve constitutional order."

According to Reuters, a military takeover in the former French colony could further complicate Western efforts to help countries in the Sahel region fight a jihadist insurgency that has spread from Mali over the past decade.

Meanwhile, President Tinubu met his Beninoise counterpart, Patrice Talon, over the attempted coup.

At the meeting with Talon at State House, Abuja, President Tinubu told journalists that the meeting dealt with ways to resolve the problems that caused the coup attempt in Niger Republic

The Nigerian President said the Beninoise President was heading to Niamey to see things and report back to him as the Chairman of ECOWAS.

On his part, President Talon said "the situation is serious enough that ECOW-AS and President Tinubu as the President, and the President of Nigeria, a neighborhood country of Niger Republic, with Benin Republic of which I am the President, also a neighborhood country of Niger, for us to take it seriously and act quickly.

"I believe that all means will be used, if necessary, to restore constitutional order in Niger, but the ideal would be for everything to happen in peace and harmony.

"So, as the president has

committed, the mediation actions will be reinforced this very evening so that this situation can be settled in peace, between brothers because even when what is not acceptable is done, it is necessary that in peace, we can correct this. This is our first option and we think it will be a success."

NLC strike notice, contempt of court -FG

ederal Ministry of Justice said that the seven-day notice issued by Nigerian Labour Congress (NLC) to embark on strike is in contempt of the order of National Industrial Court (NIC) and would attract adverse consequences if they went ahead with the industrial action.

A statement signed by Solicitor-General of the Federation/Permanent Secretary, Federal Ministry of Justice, Mrs. B.E. Jedy-Agba, referred to media reports which indicate "that the National President (Joe Ajaero) and Secretary-General (Emmanuel Ugboaja) of the Nigeria Labour Congress (NLC) endorsed a 7-day notice of their intention to embark on a nationwide strike action from 2nd August 2023 if the demands of the labour unions are not met."

The Ministry said it is pertinent to alert the NLC and the general public to the pendency of suit number: NICN/ABJ/158/2023 - Federal Government of Nigeria & Anor V. Nigeria Labour Congress & Anor before the National Industrial Court, wherein His Lordship, Anuwe, J., on 5th June 2023 granted an injunctive order restraining Nigeria Labour Congress and Trade Union Congress from embarking on the planned industrial action/or strike of any nature, pending the hearing and determination of the pending Motion on Notice."

The said motion on notice also prayed for an order of interlocutory injunction for parties to maintain status quo pending the determination of the dispute or issues submitted to the court, she explained, adding that the said Motion on Notice is still pending.

Jedy-Agba noted: "It is noted that the issues (removal of fuel subsidy, hike in prices of petrol and consequential increase in cost of living etc) which precipitated the above court action, are the very same issues over which NLC has now issued another strike notice.

"The NLC has submitted to the jurisdiction of the court and is being represented by the reputable law firm of Femi Falana, SAN.

"It is therefore our minimum expectation that NLC will allow the courts perform their constitutional roles rather than resorting to selfhelp and undermining the orders of the court.

"We note with dismay that this latest strike notice is consistent with the inexplicable disdain which the NLC leadership has visited on the authority of the court in recent times following earlier inciting and derogatory remarks made by the NLC President against the court.

"Indeed, the avowed penchant of the leadership of the union for casting aspersions on the Judiciary is quite worrisome and con-

epartment of State Services (DSS) has commenced investigation into the ugly incident that occurred on Tuesday, July 25, 2023, at Federal High Court, Ikoyi, Lagos where its personnel manhandled Nigeria Correctional Service (NCoS) officials over the custody of detained ex-Governor of Central Bank of Nigeria (CBN), Godwin Emefiele.

In a statement by its spokesman, Peter Afunanya, DSS said it has noted the incident that took place between its staff and those of NCoS)

Apparently distancing itself from the conduct of its personnel . DSS said: " (i) the incident was unfortunate and does not in any way reflect the professional disposition of the DSS;

"(ii)he Service did not and would never encourage the incident under reference;

"(iii)The Service has tremendous respect for the Judiciary as an Arm and Institution of Government and will not go out of its way to undermine it."

The DSS said it recognised

the Judiciary as a critical component in nation building, national development and security management.

Also, the Service insisted that it has robust working relationship with sister security and law enforcement agencies including the NCoS.

While noting that the personnel from both agencies exhibited undue overzealousness, the Service said it initiated detailed investigations into the matter to identify the role played by specific persons as well as undertake disciplinary actions, if necessary, and drawing some lessons going forward.

It was a show of shame at the court as DSS personnel engage their NCoS counterparts in a free for all over who would take custody of Emefiele after the court granted him bail in the sum of N20million. He waited for a while inside the court to see to the perfection of his bail.

But as he stepped out of the court room, DSS operatives grabbed him even as an NCoS official moved to take him to a correctional centre pending the perfection of his bail.

Bloodbath looming in Adamawa over alleged injustice to Vomnis

ne people of Vomni community, Jada local government of Adamawa State have decried the ethnic ostracism and exclusion being meted to them by Damti people who, they said, they accommodated and gave succor in the past.

A statement by Mr. Talmon Jatau on behalf of Vomni Concerned Elders, noted that the community has been reeling under excruciating marginalization as alleged strangers are now appointed to take charge of their traditional institutions.

In an open letter to Governor Ahmadu Umaru Fintiri, a copy of which was sighted by our reporter, the community sought the governor's intervention in order to stave off an imminent confrontation as they vowed to resist the incursion of 'strangers' into their rulership.

Jatau noted that Vomni tribe has over 50,000 descendants cutting across Jada and Fufore local governments of the state, regretting that despite their numerical strength, those he described as "fifth columnists" will not allow them enjoy rights of self-determination.

"Vomni tribe/people with a population of over 50,000 living in Jada local government with spread into Fufore local government area, are peace-loving people who have been in bondage in their land under Ganye Chiefdom for over 150 years.

"From the old Ganye local government, formerly known as Koma District, was the only District that was split into two Districts only of recent under the Fresh Air Government, while her counterparts like Yelwa District, Sugu District, Mbulo District etc. have developed into two or three Districts except Koma because of persistent and deliberate insistence of un-democratic elements who vow to keep the Vomni people in perpetual bondage.

"It was the height when the Vomni people, in particular Tuli village, lost her village head in 2021 July. Instead of appointing a Vomni man in acting capacity, a tenant in their land was imposed on them. Vomni people are truly peace-loving people; when they took their complain to the authorities no one was willing to listen to them. Instead were promised that they will be given the substantive village head that they are aware it is Vomni entitlement.

"When Vomni District was created, an Acting District Head who was not a Vomni man was appointed again and our people complained to the authorities, but they were not given listening ear. Again, another promise that a Vomni man will surely be appointed as substantive. Deliberately there was no plan for fairness and justice," Jatau said.



Jatau noted that the marginalization of Vomni people could be traced to the era of the late Col. Yohana Madaki's military administration where he appealed to them to accommodate Koma Damti people when they were brought down from the mountain top for rehabilitation.

He noted that as people with high level of compassion, accommodation and milk of human kindness, they accepted Koma Damti people and gave them farmlands so that the latter can settle down to farm.

Jatau narrated: "When Late Yohana Madaki visited Koma with the mindset of rehabilitating the people, the Vomni people were approached to allow the Koma Damti, a mountain top people, access to Vomni land for farming and set-

"The Vomni people, without hesitation, consented and gave the Damti people lands for farming etc. Over time, the Damti people who came down from the mountains, started claiming ownership of Vomni land and were creating and fomenting trouble, but Vomni people refused to respond to their provocations.

"When their troubles became too much, one of the Vomni elder statesman in the land had to take legal action and secured documents for some of the lands...the conflict is still unsettled

"Additionally, Vomni District was created, and the headquarters was sited at Komni, instead of Tuli, the headquarters of Vomni,. deliberately to enslave and provoke the Vomni

people."Vomni elders were not consulted for any inputs; the authorities were misled by those who wanted to create seed of discord and communal crises in Vomni land to site the headquarters at Komni. Our people complained for the third time but we're denied listening ears.

"Finally, the process of the appointment of the district head was stage-managed and hurriedly done because as at the time the process commenced, the Tuli village head was not appointed after series of applications, interview and screening.

"When the Vomni District was created, it had four village heads under it, which are Tuli, Deggi, Samlo and Konglo. Only Deggi and Konglo had substantive village heads while Tuli and Samlo had acting village heads, meaning elections cannot be held for only two people, and one of them was contesting for the position.

"The guidelines were that those acting will not vote or be voted for; meaning only Deggi and Konglo, who are substantive appointees, can vote.

"Vomni people complained the unfair treatment and injustices they have suffered over the years, been ruled by strangers in their land, but as usual no one was willing to listen to our plea and cry for fairness and justice.

"The authorities, against the guidelines, went ahead by screening and held elections for two people. The two substantive District Heads, one out of the two was even contesting for the position.

"This observation was made but the authorities did not give listening ear to the complaints, but elections were carried out against the guidelines and appointment was done in a hurry with no recourse to the guidelines and complaints tabled by the Vomni people.

'The Vomni people on hearing the news about the announcement of the appointment, organized themselves and travelled to Ganye to see the royal father, His Royal Highness, but were denied access by those around him.

"Thereafter a written complaint was forwarded to His Royal Highest the Gangwari on the matter and copied to relevant stakeholders and Government agencies.

"It was after the written complaint that the Vomni people were invited and persuaded to accept the appointment and decision. This was the height of injustice for the Vomni and the people can no longer accept the decision to enslave them after over 150 years of bondage in our land.

"Since the announcement, there has been tension and distrust in Vomni District that requires urgent intervention of His Excellency the Executive Governor, the Fresh Air Governor, so that the Vomni people can experience Fresh Air under your able leadership before the situation deteriorates to communal clashes."

ouse of Representatives has urged the Central Bank of Nigeria (CBN) to restore operational licenses earlier revoked from 47 Microfinance Banks across the country, pending conclusion of investigation.

This followed adoption of a motion sponsored by Rep James Shuaibu Barka (Adamawa) at plenary yes-

Moving the motion, Barka noted that on May 22, 2023, the then Governor of CBN, Godwin Emefiele revoked operational license of the 47. These included Biyama Microfinance Bank Ltd in Hong Local Government Area in Adamawa State.

He said: "The reasons cited in the communication include that the banks were either inactive, insolvent, failed to render returns, closed shop, or ceased to carry on the type of banking business for which they were licensed for more than six months in contravention of the Banks and Other Financial Institutions Act (BOFIA) 2020.

"The closure of Biyama Microfinance Bank, which is the only community bank in the Hong Local Government Area, has caused undue

hardship to the people who depended on banking and financial services offered by the bank for their small and medium enterprises."

He expressed worry that closing down the only financial institution in a place where the people go through so much hardship to earn stipends to deposit or to get small loans to run small businesses for survival, would only frustrate them further and may push them into crime in order to

The lawmaker said: "After the recapitalisation of the Bank to the required N50 million share capital, it never ceased operating in line with BOFIA and has been making all required reports and returns."

He lamented that if the situation is not urgently resolved, the people will resort to keeping their money at home, which makes them easy prey for armed robbery.

APC NWC member, Lukman, resigns, cites injustice

resh controversy is rocking the ruling All Progressives Congress (APC) as the party's National Vice Chairman, North-west, Dr Salihu Lukman, has resigned his position as member of the National Working Committee (NWC), less than a fortnight after National Chairman, Sen. Lukman cited what he described as the atmosphere in the party as reason for his resignation, saying that it is completely at variance with the founding vision of forming a progressive party.

Lukman disclosed this in a letter dated July 26, 2023 addressed to the party's Acting National Chairman, Senator Abubakar Kyari.

Daily Times had reported that the

Kaduna-born politician and former Director General (DG), Progressives Governors' Forum, (PGF) vehemently opposed the speculation that immediate past Governor of Kano state, Dr Abdulahi Umar Ganduje is being propped up to assume position of the National Chairman.

Lukman insisted that moving the position of National Chairman from the North-Central geopolitical zone to the North-west was suicidal, unjust and insensitive.

The letter read: "I hereby kindly resign my position as National Vice Chairman, North-West of our great party, the All-Progressives Congress (APC).

"My resignation is with immediate effect, which becomes necessary given my conviction that the atmosphere in the party is completely at variance with the founding vision of forming a progressive

"Rather than remaining in the leadership of the party and become a source of distraction for leaders, especially the young government of President Bola Ahmed Tinubu, it is better to excuse myself and take time off from politics.

"I do hope all our leaders will appreciate that I am left with no option in the circumstance. I wish the party and all our leaders, especially President Tinubu all the best and will continue to give my modest support towards success of the party from the background."

Abuja Markets Management staff protest over leadership crisis

istressed staff members of Abuja Markets Management Limited (AMML) yesterday staged a peaceful protest to the gate of the Federal Capital Territory Administration (FCTA) pleading with the Permanent Secretary, Olusade Adesola, to expedite actions on the recent leadership crisis rocking AMML.

The staff who marched around the premises with various placards calling out the embattled and sacked former Managing Director (MD), Abubakar Faruk, said that since the inception of the leadership crisis, AMML's office at Gudu District has become a death trap.

They said staff now live in unprecedented fear and tension, following the deadly 'landmines' that the crisis has subtly created.

Recall that for the past two weeks, AMML has remained a theatre of dramas, after Faruk was sacked following the resolution of the Shareholders, with the endorsement of the Group Man-

aging Director of Abuja Investments Company Ltd, Abubakar Maina (AICL) the supervising agency over AMML.

Speaking on behalf of the protesting staff, Musa Sheleng, who is the Chairman, Senior Staff Association of Statutory Corporations and Government-owned Companies (SSASCGOC), AMML branch, decried the negative effects of the leadership tussle on the

He noted that staff members no longer feel safe, due to the heavy presence of security operatives that have continued to besiege the office.

Sheleng also demanded that the rift be settled once and for all to allow staff put in their best in discharge of their duties.

According to him, "We are here to thank the Permanent Secretary for all he has been doing towards resolving the issues. But we are saying that he needs to do more, because we are living in bandage.

"We are in an office where we can't express ourselves. Some of us have been here as old as the company itself, but now the decision has brought enmity, and we are living in fears. You don't know what happens as you come to work.

"It has been one episode of trouble to another. We want FCTA to stamp its final authority over the matter. We are aware of the Court cases, but we are saying the Permanent Secretary should come to the aid of AMML staff, so that we can have a lasting solution. The facilities and markets and staff are suffering.



Israel's judicial overhaul sparks military crisis as number of refusing reservists grows

s Israel plunges deeper into crisis after the country's parliament passed the first bill of a controversial judicial overhaul, thousands of Israeli army reservists - the backbone of the Israeli military – are threatening not to show up for work. And Israel's leaders are sounding alarms about the country's readiness for war.

The law that came into effect on Wednesday took away the court's power to veto government decisions based on them being "unreasonable." Millions opposed the change, according to opinion polls, which critics said would erode the independence of the courts and harm Israel's democracy.

"At the current point in time, the IDF (Israel Defense Forces) is competent," IDF Chief Spokesperson Rear Adm. Daniel Hagari told reporters on Tuesday, but he acknowledged that the country's military readiness could be affected.

"If reservists do not show up for a long time, there will be damage to the army's competence. It is a gradual process that will be affected according to the presence of the reservists," he said.

The threat is unprecedented in its scope, experts say, and the military has pleaded with reservists to remain in their posts.

"The IDF needs you – only together will we protect our common home," IDF Chief of General Staff Herzi Halevi said Tuesday, addressing reservists who refused to show up for service.

Nearly 10,000 military reservists said before the passage of the controversial "reasonableness" bill on Monday that they would refuse to volunteer for duty if it was passed. And the number of refusers is growing, according to Hagari.

US Secretary of Defense Lloyd Austin spoke by phone with Israeli Minister of Defense Yoav Gallant and reiterated the US' commitment to Israel's security. But he also said that "broad consensus through political dialogue" was critical to maintain democracy.

Chuck Freilich, a senior researcher at The Institute for National Security Studies (INSS) in Tel Aviv who served for over 20 years in Israel's national security establishment, said that Israel is at a historical "inflection point," in which "extreme measures may have to be taken to endure Israel's fundamental character of democracy."

Speaking about reservists refus-

ing, Freilich said that "on the one hand, it is admirable." But on the other hand, he said, "it is a horrible thing for the IDF." It was remarkable, he added, that one of the world's better militaries "is threatening to come apart at the seams over domestic changes."

When the vote passed on Monday, Israeli Prime Minister Benjamin Netanyahu called on the IDF to "stay out of any political controversy," saying that "the call for refusal harms the security of all citizens of the country."

The 'backbone' of Israel's military A country that went to war shortly after its founding in 1948, Israel has fought seven wars and engaged in several other smaller

conflicts with its neighbors.

Every Israeli over the age of 18 who is Jewish, Druze or Circassian must serve in the military, an institution that is deeply entrenched in many Israelis' sense of identity and nationhood.



Ukraine MP under criminal investigation over Maldives holiday

krainian authorities are investigating whether a member of parliament broke the law when he took a family holiday to the Maldives.

Officials are banned from travelling abroad on holiday, while men of conscription age need special permission to leave the country.

The security service opened a criminal case to assess whether Yuriy Aristov gave false information to authorities.

He could face up to three years in jail if convicted, investigators

The State Bureau of Investigation (SBI) and the Security Service of Ukraine have opened a criminal case to establish whether Mr Aristov gave false information in applying to leave the country.

The SBI said initial investigations found that Mr Aristov had been on the private island of Ithaafushi in the Maldives in mid-July with his wife and children, when he was registered as being on sick leave.

He was abroad from 5 June to 22 July, having first left for a threeday business trip to Poland. He was first spotted in the Maldives by Ukrainian media.

Ukrainian President Volodymyr Zelensky warned public servants in a speech on Tuesday that any betrayal of the country's interests would trigger "fury".

"When you constantly see and feel the moral strength gained for Ukraine by our warriors, our people, who are doing everything possible and impossible for the victory and preservation of freedom, any internal betrayal, any 'beach' [holiday] or any personal enrichment instead of Ukraine's interests triggers fury at the very least," he said.

Mr Aristov has handed in a letter of resignation which will be discussed in the next parliamentary session, parliament speaker Ruslan Stefanchuk said on Face-

Several senior Ukrainian officials resigned earlier this year after Mr Zelensky began a shakeup of personnel across his government. Their departures came as the Ukraine launched a broad anti-corruption drive.

Hunter Biden: Plea deal for president's son collapses in dramatic court hearing

n agreement expected to see US President Joe Biden's son, Hunter, plead guilty to tax charges and admit a gun offence has dramatically fallen apart

The plea deal, negotiated over several weeks, was likely to spare the younger Mr Biden prison time.

But a judge on Wednesday said she could not "rubber stamp the agreement".

The case marks the first time the justice department has charged the child of a sitting president.

Hunter Biden's lawyers have been given 14 days to hash out a new deal with the prosecution.

It follows a five-year investigation into the finances of the US first son, who arrived on Wednesday morning at the court in Wilmington, Delaware.

In a plea agreement announced last month, he was to be charged with two misdemeanour counts for failing to pay his taxes on time in 2017 and 2018.

He was also to admit that he had illegally possessed a gun while being a drug user, and agree to drug treatment and monitoring in lieu of a more serious felony charge and possible jail time.

But during the three-hour hearing, US District Court Judge Maryellen Noreika questioned whether the deal would also provide Hunter



Biden with immunity from crimes he could be found liable for in the

She said the agreement contained "non-standard terms" and its proposed resolution for the gun possession offence was "unusual".

Officials with the justice depart $ment\ are\ still\ investigating\ whether$ Hunter Biden violated federal laws that required him to register as a foreign agent while working in China and Ukraine during his father's vice-presidency, CNN reported.

Legal teams for both sides were seen negotiating in full view of reporters inside the court in an effort to salvage the plea deal or carve out a narrower agreement.

But the hearing ended with Judge Noreika, a Trump appointee, declining to sign the deal. She gave the two parties a fortnight to reach a new agreement and brief her.

Hunter Biden, who initially offered to enter a guilty plea, ended by pleading not guilty for the time

In a statement on Wednesday, the White House said the president and first lady "love their son and they support him as he continues to rebuild his life".

'Hunter Biden is a private citizen and this was a personal matter for him," said press secretary Karine Jean-Pierre.

Stocks market loses N186.85bn over selloffs in MTNN, others

he equites market on Wednesday ended its four-day winning streak, due to selloffs in telco heavyweight, MTN Nigeria alongside FBN Holdings and WAPCO, as market capitalization lost N186.85billion to close at N35.75trillion.

At the close yesterday's trading activities, the domestic bourse closed in red, while the benchmark index shed 0.46 per cent to close at 65,687.16 points.

Specifically, selloffs in telco heavyweight, MTNN (- 3.44%), FBNH (-4.87%) and WAPCO (-0.36%) underpinned the market's weak performance, despite gains in ZENITHBANK (+0.86%), SEPLAT (+10.00%) and STANBIC (+2.96%).

A total of 500.43m shares valued at ₩7.14bn were exchanged in 7,345 deals. UBA (-0.67%) led the volume chart with 58.31 units traded while ACCESSCORP (-4.72%) led the value chart in deals worth ₩991.20m.

Market breadth closed positive at a 1.53-to-1 ratio with advancing issues outnumbering declining ones. SEPLAT (+10.00%) topped twenty-five (25) others on the leader's log while UNILEVER (-10.00%) led sixteen (16) others on the laggard's table.



NCAA warns airlines overwriting CVRs after serious accidents

he Nigeria Civil Aviation Authority (NCAA) has issued an All Operators Letter (AOL), warning domestic airlines against overwriting the Cockpit Voice Recorder (CVR) of aircraft after serious incidents and accidents.

The civil aviation authority in the (AOL) with reference number: NCAA/DGCA/AOL/ 11/16/365, signed by Capt. Musa Nuhu, the Director-General Civil Aviation (DGCA), stressed that airlines' indulge in the unprofessional act in order to circumvent investigation by the Nigeria Safety Investigation Bureau (NSIB).

The letter dated July 24, 2023, addressed to Accountable Executive, Directors of Operations, Chief Pilots and Safety Managers and obtained by our reporters, emphasised that some airlines have consistently indulged in this unwholesome practice, which could impact safety negatively.

The CAA further issued them a 30 days ultimatum to comply with the amendments or face sanction.

The letter to all Accountable Executive/Director of Operations/Chief Pilot/Safety Manager titled: 'Re: Continuous Overwriting of Cockpit Voice Recorder (CVR) Information Aviation read'.

The Nigeria Civil Aviation Authority (NCAA) had noticed that some airline operators' flight crew members were in the practice of continuously overwriting the CVR information after an occurrence.

"This practice makes it practically impossible for the

Nigerian Safety Investigation Bureau (NSIB) to retrieve actual data to aid in its investigation as required by Paragraphs 25 and 26 of the Civil Aviation (Investigation of Air Accidents and Incidents) Regulations 2019. This action has also impeded and posed undesirable difficulty in ensuring that NSIB successfully discharge its statutory mandate of investigating accidents and serious incidents.

"Unfortunately, this unwholesome practice has recently been detected in the industry. The Authority, by this AOL, wishes to reiterate that Nig. CARS Part 7.8.1.3 (b), which is derived from the provisions of ICAO Annex 6, Section 11.6 states that, "To preserve flight recorder records, flight recorders shall be deactivated upon completion of flight time following an accident or incident. The flight recorders shall not be reactivated before their disposition as determined in accordance with the accident incident regulations of Nigeria.

"Furthermore, Nig. CARS Part 8.14.10.3 (a) requires that "The operator/owner of the aircraft, or in the case where it is leased, the lessee, shall ensure, to the extent possible, in the event the aircraft becomes involved in an accident or incident, the preservation of all related flight recorder records and, if necessary, the associated flight recorders, and their retention in safe custody pending their disposition as determined by the Accident Investigation Bureau (now NSIB)."

CBN lifts post no debit ban on 440 accounts

* Instructs banks to notify affected customers

he Central Bank of Nigeria (CBN) has instructed banks to remove the Post No Debit (PND) restriction placed on the bank accounts of 440 individuals and companies in the country.

A post-no-debit is a restriction placed on an account to stop the account holders from carrying out debit transactions, including ATMs and cheques, but the accounts can receive inflows.

The accounts whose PND restriction were lifted included that of betting, energy, technology, and fintech firms.

A letter dated July 25,

2023, signed by A.M. Barau on behalf of the CBN director of banking supervision, and issued to all banks in the country, directed that all PNDs on the 440 accounts be vacated.

PND is a restriction on an account which stops an account holder from carrying out debit card transactions, money transfer out of the



account, and check transactions. When an account is placed on Post No Debit, it means the customer cannot conduct any banking transactions in the country of jurisdiction.

On the list of the 440 account holders that the CBN directed that banks vacate the PND include; Bamboo Systems Technology Limited, Escale Oil & Gas Limited, Rise Vest Technologies Limited, Chaka Technologies Limited, abokiFX Limited, Nairabet International, Northwood Energy Services and Proport Marine Limited, among others.

In 2021, CBN instructed

banks to freeze the accounts of 18 companies, ranging from bureaux de change, construction firms, investment companies, laundering services, and property companies.

The affected companies included; Bakori Mega Services, Ashambrakh General Enterprise, Namuduka Ven-tures Limited, Crosslinks Capital and Investment Limited, IGP Global Synergy Limited, Davedan Mille Investment Limited and Urban Laundry.

Others were Advanced Multi-Links Services Limited, Spray Resources, Al-Ishaq Global Resources Limited, Himark Intertrades, Charblecom Concept Limited, and Wudatage Global Resources.

Treynor Soft Ventures, Fyrstrym Global Concepts Limited, Samarize Global Nigeria Limited, and Zahraddeen Haruna Shahru were also included. All 18 companies have had their bank accounts unfrozen by the apex bank.

Lagos startups raise \$820m in early-stage funding

tartups in Lagos raised around \$820 million in early-stage funding which was the highest in the Sub-Saharan startup ecosys-tem, a report has revealed.

The report by policy and advisory research firm, Startup Genome, also revea-led that, the Lagos startup ecosystem calculated using the value of exits and startup valuation from the second quarter of 2020 to 2022 was valued at \$8.4 billion, thereby, placing the state as regional leader in the Sub-Saharan startup ecosystem in terms of the value of the ecosystem and the amount raised in funding.

The report disclosed that Lagos was closely followed by Nairobi and Cape Town with total startups valuation of \$7 billion and \$3 billion respectively. The report also revealed that Lagos held its place in the range of 51 and 60 in the global emerging startup ecosystem ranking.

In terms of the amount raised in funding, the report stated, OPay's \$400 million Series C in August 2021 was the region's biggest deal, while Flutterwave's \$250 million Series D in February 2022 saw its valuation increase to over \$3

Findings from the report also show that Venture Capital (VC) funding in the region declined by six per cent from 2021 to 2022. Fintech was the region's top-performing technology sector comprising 41 per cent of total startup deals between 2018 and 2022. Nairobi was reported to be the region's biggest fintech hub.

The report, therefore, noted that 88 per cent of tech startups in Nigeria are in Lagos amounting to over 400 startups, adding that the Lagos tech ecosystem is dominated by fintechs which constitute 49 per cent of tech companies in the city.

t least a total of 316 Bimodal Voters' Accreditation System (BVAS), machines presented before Justice Victor Oviawe led panel have subsequently been admitted as exhibits at the governorship tribunal sitting in Kaduna, at the resumed hearing on Tuesday.

The BVAS machines were admitted as exhibits based on the subpoena served on the Independent National Electoral Commission (INEC), to bring them before the court, the said items as applied by the 1st and 2nd petitioners, Hon. Isa Ashiru and the People's Democratic Party (PDP), through their counsel, Samuel Atung (SAN).

INEC representative, Yusuf Zubairu who was at the court on behalf of the Commission made a written statement on oath before the registrar of the tribunal to present BVAS machines of 19 Local Government areas of the In his deposition before the court; the Commission was subpoenaed "on Duces Tecum (to tender) and Duces Tecum Ad Testificadum (to tender and testify) and demonstrate how the machines were used to collate election results in the state at the last gubernatorial polls.

However, Zubairu who is a staff of INEC at the ICT/ Voters' Research Department testified that the results on the Irev was the true reflection of the votes cast during the 18th March, 2023 gubernatorial election in the state.

Meanwhile, one of the prayers of Ashiru and his party before the tribunal was that they won the election going by the Irev results, as alleged.

Zubairu, who is a witness also added that the BVAS machines could not be tampered with, either before, during or after the election, just as he explained to the court that each machine has its unique identity numbers.

The witness, while demonstrating, by using one of the machines, told the tribunal that polling unit 050 of Makera ward in Kaduna South LGA had

715 total voters register, but 107 voters were accredited.

Earlier In his defence before the tribunal granted the application of the 1st and 2nd petitioners' counsel for the witness to demonstrate by using the BVAS machines, Chief Duro Adeyele (SAN) who is the counsel to the Kaduna state Governor, Dr. Uba Sani, objected to the admissibility of the BVAS machines through the witness.

The counsel also argued that the witness' deposition did not state that the witness (Yusuf Zubairu) would open and demonstrate the BVAS machine before the tribunal.

"Demonstration of BVAS' machine is not in the witness' statement," the counsel emphasized.

In his counter, the Ashiru and PDP's counsel said that the Commission was subpoenaed to (Duces Tecum Ad Testificandum) tender and demonstrate the machine before the court.

The court adjourned the case to 26th July, 2023 for the continuation of the hearing of petition.

Diphtheria: Senate directs Health Ministry, Centre to prevent spread

...wants FG to carry out nationwide vaccination

he Senate on Wednesday raised the alarm on why the communicable disease known as diphtheria should be curtailed.

The upper chamber has therefore directed the Federal Ministry of Health, National Centre for Disease Control and National Primary Health Care Development Agency to halt further spread of the disease.

The lawmakers as well called on the Federal Government to increase funding for all institutions

involved in the production and distribution of vaccines so as to effectively tackle the prevalence of communicable diseases in Nigeria.

The red chamber also directed relevant agencies to carryout a nationwide vaccination to curb the spread of Diphtheria in the country.


The Senate's resolution followed the consideration and adoption of a motion sponsored by Senator Sunday Katung representing Kaduna South Senatorial district.

Senator Katung noted that the spread of Diphtheria in Kaduna has resulted to several deaths in the state and its environs.

He noted that the airborne disease which can also be transmitted via fluid exchange has become a major health challenge that requires urgent government attention.

He said Kaduna State government has confirmed that the death toll from the diphtheria outbreak in the State has risen to 17 with 68 suspected cases identified across the state as at Sunday the 23rd of July 2023;

Katung noted that a breakdown shows 10 people have reportedly died from the disease in Kafanchan, Jema'a Local Government Area of



Kaduna State, while 3 children died in Makarfi Local Government Area, while seven others were hospitalized;

He also disclosed that diphtheria is a highly contagious, infectious disease caused by a bacterium called Corynebacterium diphtheria rendering infected people struck with serious breathing and swallowing problems that may develop sores on the

"The highly contagious nature of the disease means that without immediate and concerted efforts towards curbing it, the disease would spread at a devastating rate especially considering the communal and poor living conditions in most rural communities in Nigeria", Senator Katung stressed.

In his contribution to the motion, Senator Darlington Nwokocha representing Abia Central Senatorial district lamented the state of government control hospitals in the country especially the National Hospital in Abuja.

He said Nigeria should stop fire brigade approach to issue of health in the country while urging the Senate to suspend plenary one day and pay visit to the national hospital to assess the level of decay and poor medical facilities.

he Nigerian media has been described as critical to success of electoral processes in the country.

Chairman, Independent National Electo-ral Commi-ssion (INEC), Prof. Mahmood Yakubu passed this note if confidence on the media Wednesday at the meeting with media executives and heads of various media organisa-tions at the Commission's headquarters, Abuja.

He also acknowledged the long-standing partnership between the Commission and the media which he called critical stakeholders.

"Bevond voter and civic education, we regularly consult you ahead of the formulation of policies or the imple-mentation of activities. Media organisations are also accredited to cover elections and electoral activities. Beyond reporting on our activities, we are also convinced that as citizens you should be part of the discussion for the overall improvement of our electoral process based on your field observations," he said.

While accepting that there were challenges despite the many positive aspects of the 2023 General Election, the chairman said the Commission expected at the meeting media practitioners from their practical experience of reporting or analysing the election, would loutline their observation and make useful suggestions on the processes and procedure for future elections.

"The Commission would like to share with you our plans for pending bye-elections and preparations for the off-cycle Governorship elections in Bayelsa, Imo and Kogi States scheduled to hold on Saturday 11th November 2023," he said.

Women protest against Deputy Gov over community election

omen of Mbaukwu, Awka South Local Government Area (LGA) of Anambra State have warned the state Deputy Governor, Dr. Onyekachukwu Ibezim to leave them alone and concentrate on his job as number two.

The women gave the warning during a protest to register their displeasure and dissatisfaction with what they described as an unwarranted high-handed interference from some government officials in the leadership matters of their community women's union.

During the peaceful protest on Tuesday, the visibly unhappy women stormed the streets, the market square, the Civil Centre, the Igwe's (monarch) Palace and other places, with placards bearing different inscriptions that represent their position on the matter.

Some of the inscriptions read 'No Crisis for Mbaukwu Women', 'No to Imposition', 'Deputy Governor Face Your Work', among others.

Expressing their grievances at the palace of Igwe P. N. Anagwu of Mbaukwu, the women regretted that after they conducted the Town Union leadership election for the women of the community on June 8, 2023, and elected new leadership (with Mrs. Theresa from Akabor village as the president); the then Women President-General of the community, whose tenure had expired, did not hand over to the newly elected leadership long after it was due.

The women said that as they were clamoring for a hand over, the next thing they saw on the social media was the news that another leadership (Caretaker Committee) had been constituted and inaugurated already in Awka, the state's seat of power, for women of the community. The Committee was said to have been inaugurated by the State Commissioner for Women Affairs, Mrs. Ify Obinabo.

The women said the news did not only come to them as a shock, but also saddened them, as they kept wondering when, how and by whom the said new leadership was elected. They said they also wondered why the said inauguration of the so-called new leadership held in Awka, rather than in Mbaukwu, which has been the usual venue for inauguration of the community's leadership since the town's history.

According to them, the Commissioner, in the letter announcing the inauguration of the said Caretaker Committee, imposed her choice of leaders on them, without any consultations.

As was observed by this reporter, the letter from the Commissioner positioned CJ Nebechukwu Stella Obiageli as Chairperson of the Caretaker Committee and Leader of the women, stating also that the Committee would oversee the affairs of the women leadership in the community for one year before election would be held.

The women further explained that the Commissioner, in her reasons for the creation and inauguration of the Caretaker Committee, cited crisis in their Union's leadership and their disobedience after she warned them not to hold the June 8 election until government officials were assigned to supervise it, which they ignored and went on with the election, without any government delegation present to witness the election.

Be that as it may, the Mbaukwu women, who denied any crisis was rocking the women union of the community, also opined that the Deputy Governor of the State, Dr. Ibezim, who also hails from the community, may not be far from the influence behind the Commissioner's action (the inauguration of the Caretaker Committee), alleging that he (the Deputy Governor) had "not been at rest' since his candidate in the June 8 women election absconded and also failed woefully after he had wished her to emerge."

The women also accused the Deputy Governor of probably been determined 'to frustrate the inauguration of the newly elected leadership as it was not his candidate that emerged. This, they further alleged, might have pushed him to leverage his influence to ensure the imposition of another person on the women as Caretaker Committee Chairperson, as done by the Commissioner, rather than seeing the elected executive occupy that position.

The women also wondered why the Commissioner did not make plans for conducting fresh election since she said her reason for not upholding the June 8 election was because the government officials were not on ground to

However, when contacted by this reporter, the Commissioner, Mrs. Obinabo attested that the women went against

her directive by conducting the election without any government official present to monitor it; hence her Ministry's decision to constitute a Caretaker Committee for them, to lead them for 12 calendar months before another election is held.

When asked why her Ministry chose not to conduct a fresh election rather than impose an interim leadership on them, as the women complained; the Commissioner simply told this reporter that the women were not supposed to order the Ministry on what to do.

"Are they supposed to order us? Don't we have our own schedule? ...I don't know what they're talking about," she

Efforts made by this reporter to get the reaction of the Deputy Governor on the matter proved abortive as he did not pick his calls or reply to message sent to his phone, as of press time.

CPPE laments impact of money supply on FX market

he President of the Centre for the Promotion of Private Enterprise (CPPE), Dr Muda Yusuf, has said that broad money which grew by over N9 trillion, from N55.7 trillion to N64.9trillion is pressuring the naira in the foreign exchange market.

He explained thatthe Money supply grew by an unprecedented 15 per cent in one month between May and June 2023, noting that Broad money grew by over N9 trillion, from N55.7 trillion to N64.9 trillion. "This surge in monetary growth is unprecedented."

According to a statement titled, "The Naira Exchange Rate Conundrum," the CPPE boss cited that the monetary authorities should come up with a sustainable intervention framework to ensure the moderation of current volatility in the forex market. "We recognize the forex supply limitations, but the system needs to be managed in a way that would not undermine investors' confidence."

"The monetary authorities should investigate this drastic growth in money supply and take steps to curb subsequent expansion. Such dramatic growth in money supply poses a significant risk to macroeconomic stability, especially price stability."



He lamented that, over the last few years there had been a cumulative backlog of unmet foreign exchange demand, running into billions of dollars as a result of acute illiquidity in the foreign exchange market.

"With a more liberalized forex market, the pressure of the backlog of unmet demands and other maturing forex related obligations have been unleashed on the investors and exporters window."

"Transiting from a repres-

sive market environment to a more liberalized market could be a source of market instability. However, there is a need for vigilance to prevent questionable capital outflows or speculative assaults on the currency. A free market is not synonymous with a complete absence of regulation. Free enterprise has to be complemented with an appropriate regulatory framework to curb illicit financial flows."

"It is evident that the frequency and scope of Central

Bank of Nigeria, (CBN) intervention in the forex market had decelerated compared to the first five months of the year. Recent reports from the CBN indicate a total of \$17 billion in intervention by the CBN in the forex market in 2022. This is an average of N1.4 billion per month.

"Since the inception of the present administration, it is doubtful whether we had seen an intervention of up to \$1 billion in total. It is expected that as the scale of intervention improves, the volatility will be subdued. And only recently, the government paid \$500m to settle matured debt service obligation on Eurobond. This could also be a constraining supply-side factor.

"The marginal decline in foreign reserves was also disproportionately amplified by the media This also created some anxiety which could also have driven speculative activities in the forex market."

The CPPE believes that the Tinubu administration is on the right path and that the current volatility in the foreign exchange market is ca challenge typically inherent in a major policy transition. In a couple of months, we expect the instability to subside.

FG sets up committee to review National Youth Policy

n line with the timeline for the review of the National Youth Policy (NYP), the Federal Government has inaugurated a 27man Committee to immediately commence work on the 2019-2023 National Youth Policy.

The Permanent Secretary, Federal Ministry of Sports and Youth Development, Alhaji Ismaila Abubakar while inaugu-rating the Committee yesterday in Abuja, said that the aim of setting up the Review Team by government was to ensure that the Ministry has a befitting Policy Document that will serve as a guide for the development of the nation's teeming youth.

"The National Youth Policy, like other government policies, is the handbook of the Federal Ministry of Youth and Sports Development's guide on youth development as it represents the declaration of the Nigerian Government to the practical support it intends to give to its youth." He said Speaking further, he said that the 2019-2023 Edition of the National Youth Policy is in the last lap of its journey, especially as the policy itself stipulates a 5-year periodic review, hence the need for the commencement of this process.

Alhaji Ismaila informed that part of the successes recorded in the implementation of the 2019-2023 Edition of the NYP by the Federal Government includes Youth inclusion, participation, and access to information, which enables them to know their rights.

The Ministry, in partnership with the Civil Society Organizations, Private Sector and International Agencies, he said, has through enlightenment and publicity, taken National Youth Policy to the grass-

He added that various programmes and projects were also implemented across the six geo-political zones in line with the policy thrust of government.

Ismaila explained that the periodic review of the NYP quidelines has become imperative, particularly due to the dynamic nature of human endeavour, which he emphasised is not static. "It is the dynamic nature that has prompted the review of the guidelines in human activities in order to get better results", he

The Permanent Secretary observed that, there have been a lot of changes in the perception and actions of Nigerian youth towards government policies in the last five years, especially in this era of Information Communication Technology (ICT).

Besides, he said, "the age range of youth (15-29) in the current Edition of the NYP has generated a lot of debate and controversy, as it appears to fall short of Nigeria cum Africa youth age reality; thus the justification for the review to address the current

The Permanent Secretary noted that it is in view of these that the government approved the commencement of the review process with the formation and inauguration of the Committee, which is expected to work from now to February 2024.

While charging the Committee to bring their wealth of experience to bear in ensuring that they produce a one stop shop Policy Document for implementation by government, he stated that other terms of reference for the Team is to amongst others; oversee the entire review process of the National Youth Policy 2024-2027 until its launching; ensure integration of youth concerns from each geopolitical zone into the final policy document; ensure that the new policy is in tune with global trends; supervise the various consultations with stakeholders during the review process; as well as bring up any other activity that will add value to the process.

Alhaji Ismaila com-

mended all relevant stakeholders for their support in ensuring the success of previous reviews as well as implementation of the editions.

The Permanent Secretary therefore called on development partners and other relevant stakeholders to put all hands on deck, work assiduously and note "that it is our collective responsibility to continue to ensure youth issues are mainstreamed into National Agenda".

He assured that the Ministry will not only continue to maintain open doors to partnerships and collaborations but also repose confidence on the ability of the team to live up to its task of producing a new Policy for Nigerian Youth in line with the policy thrust of the President Bola Ahmed Tinubu-led Admini-

Our wrong mindsets have brought about wrong orientations, eroded value system, and a thwarted worldview of ourselves and

issues.

Interestingly, the 'Meffy' syndrome' represents the way of thinking and mindsets of many of our citizens particularly the political elite and public office holders as exemplified by the likes of Abubakar Malami, Ned Nwoko, Abdulrasheed Maina, Diezani Alison-Madueke and many others.

The Nigerian nation is indeed at crossroads and never before have we had it so colourful. Every Nigerian at home and abroad feels it so bad one way or another. But for most of us, it does seem that there is very little we can do to improve things. This is because the path to the much-needed transformation is riddled with immense diffi-culties; with near impossi-bilities, some will say.
