

Get ready, fuel prices will still go up...or down -NNPCL tells Nigerians

mid nationwide anger over the latest fuel price increase, Nigeria National Petroleum Corporation Limited (NNPCL) has explained reason for the hike.

Group Chief Executive Officer (GCEO), NNPCL, Mele Kyari, blamed the recent increase in fuel price from N540/litre to N617/litr, on what he described as market forces.

Addressing State House correspondents after meeting with Vice President Kashim Shettima at the Presidential Villa, Abuja, Kyari said the sudden increase of fuel pump prices was merely market forces at

Kyari explained that the fuel price increment was not as a result of shortage of supply of products, but that rather the forces of demand and supply in the marketing value chain were working.

He told Nigerians to brace up as the price is bound to go up or down,

shot sky-high from the relatively stable N500 or thereabouts a litre to a new high of over N700 a lire in parts of the country.

Instantly, transportation fares hit the roof in some cities, prices of foodstuff and services were also

jerked up, with queues returning in some filling stations across the country.

Of course, ordinary Nigerians, already groaning from the dire socio-economic effects of the removal of fuel subsidy by President Bola Tinubu, has on their lives, complained loudly about the fresh effects the new petrol price hike.

"They want to lead people to hell in this country," a visibly frustrated man told Daily Times in Abuja,

the nation's capital.

Rights group, Human Rights Writers Association of Nigeria (HURIWA) and some prominent Nigerians have condemned the latest increase.

ECOWAS leaders now battle-ready to fight terrorism, funding no problem -Tinubu

resident Bola Tinubu, who is also Chairman of ECOWAS Authority of Heads of State and Government, has stated that the security challenges in the West Coast had been thoroughly

reviewed and a properly funded strategy would be instituted to tackle terrorism.

President Tinubu made the disclosure about a new approach by ECOWAS leaders to tackle security, with more measurable results, yesterday, after a meeting with Presidents of the Republic of Benin, Patrice Talon; Guinea-Bissau, Umaru Sissoco Embalo; and Niger Republic, Mohamed Bazoum, at the State House, Abuja.

'We have no problems raising funds. We believe we have the instruments to do that. We believe we are capable of raising necessary funds to combat terrorism in the sub-region," the President told newsmen.

President Tinubu noted that West African leaders had had extensive deliberations on sus-

But Nigeria National Petroleum Company Limited (NNPCL), which increased the price regime, called for understanding, saying prices will stabilize.

Daily Times reporters from different parts of the country, who went round to observe the situation on ground, report that the price hike is not well-received.

Ogun State

In Abeokuta, the Ogun State capital, motorists expressed shock as petroleum otherwise as fuel dealers jerked up the pump price from N500 to between N580 to N700 per liter.

A check by our correspondent revealed that a liter of fuel was dispensed for N700 by independent marketers while major marketers, who have the product, dispensed at N580 per liter.

The sudden increase forced the inter-state transport fares to go up astronomically while intra-state transporters also charged more.

At one of the filling stations in Ake, opposite the Local Government Secretariat, motorists were seen in queues lamenting the non-availability of the product despite its high price.

A vulcanizer, Babatunde Adekunbi, who was at the filling station, said the timing for the increase was wrong and called on the Federal Government to look into the issue.

He said the government's promised palliatives may not have any impact on the masses, with the way prices were going up.

Due to the current situation, Daily Times noticed that very few vehicles were plying the streets in the capital city.

Consequently, taxi fares increased rose sharply from N100 to N200 and N240 per drop.

The situation was the subject of discussion by the persons who condemned government's action as "unfeeling."

Edo State

In Edo State, residents expressed alarm and shock at what they described as "the sudden increase" in the pump price of PMS to 617 per liter.

The NNPC filling station on Sapele Road, Benin City, the State capital, sold the product at N617 per liter yesterday as against other filling stations selling as high as N620 and above.

When Daily Times visited Zico Oil and Elilove, it was discovered that both filling stations were selling at N620 as they have since adjusted their pump prices. A civil servant, who spoke on the condition of anonymity, rained curses on certain officials of the Federal Government, saying, among other invectives, that "it will not be well with them for punishing us unnecessarily."

In Abuja, the seat of power, filling stations adjusted their pump price to N617

Daily Times investigations showed that the product, earlier sold for N537 per litre, has been increased even at NNPC filling Sta-

Consequent upon this, long queues were observed in several filling stations in Federal Capital Territory (FCT) as many persons resorted to panic buying of petrol, obviously unsure if there will not be further immediate price increases. In Maitama, Jabi, Wuye, Nyanya and Karu, some filling stations were said to be selling at the old price of N537, which led to long queues.

Some marketers also adjusted their price to the new rate of N617 and some N620.

A manager of one the stations which was selling petrol at the old price, and who does not want his identity mentioned in print, said his station will soon adjust its pump to the new rate before the day runs out.

A motorist, David Uwakwe, who spoke with Daily Times, described the development as a crazy situation adding: "Is this the renewed hope we are promised? We were still battling with N537, see where they have brought us! What do they want us to do in this country? We were still battling with that new price and within two months now, they increased it again; this is not fair to the masses."

Oyo State

Residents of Ibadan, the Oyo State capital, woke up on yesterday to be confronted with the increase -a development that has caused complaints and further gnashing of teeth. Investigation conducted by Daily Times indicated that petrol price has jumped from a little over N500 per litre to N617 at NNPCL out-

Lamenting the development, residents and motorists have been complaining bitterly over Federal Government's style of handling the petroleum sector, with many saying the development would bring more hardship on the people. Indeed, the adverse effect

He said none of the filling stations, apart from Samalis Filling Station, along the stretch of Olounde-Ologuneru – Eleyele Road was open for business.

He added that even Samalis that opened, insisted on selling at N700 per litre, maintaining that he had to continue towards Eleyele – Sango Road before he got an outlet that sold at N600 per litre.

As a result of his experience, he said he had marginally increased his fare until he ends business before evening.

A commuter told journalists that "Nigerian's well-being and standard of living are being threatened," berating the Federal Government for not providing palliatives before removing the fuel subsidy.

As of the time of compiling this report, many petrol stations in Ibadan were locked, with some customers claiming that they had the stations had the product but were hoarding it to maximize profit.

"We bought fuel yesterday and even at the weekend. Why are they suddenly not selling now because they heard that NNPC has increased?", queried a commercial motorcyclist who simply identified himself as Ismail.

Delta State

In Asaba, the Delta State capital, our correspondent reports that hard times seemed to have overwhelmed residents of the State, especially in Asaba,

as prices of food items have shot up.

Motorists in Asaba, Ibusa, Okpanam, Ughelli and environs increased transport fare with reasons because of the pump price hike of petrol. Hitherto, it sold for N520 a litre, but now it is N670,00---a situation residents described as "too unbearable considering the high cost of living at present."

Due to the increase, presently a three-bedroom apartment in Asaba ranges between N2.5million and N3 million, while self-contained apartment, which used to be N80,000 to N120,000, is now N300,000, and a one-room apartment goes for N120,000 a year. Further investigation re-

vealed that the hellish situation, since the last fuel price hike, has also increased commercial sex workers' activities during nightfall to meet up their rent and other needs.

Yesterday, Asaba, and environs witnessed scarcity of fuel unlike when it was officially N520.

There were no long queues but the current pump price of N670 per litre has continued to create ripples among motorists, with some angrily raining curses on the All Progressives Congress (APC)-led Federal Government.

Some of the motorists spoke to our correspondent at the popular Oando filling station around Awai Road. One of them, Mr. Charles Urehe said: "Tinubu, Tinubu, why are we suffering again under you?" Manager of the filling station who gave his name as Nnamdi Ofon, said: "NNPC increased the pump price and we followed suit because we must also do the needful; though no long queues, but we will continue to sell at N670 until otherwise."

At Rain Oil, around Summit Junction, Asaba, in Ughelli, Warri, Ogwashi Uku, Ibusa, Okpanam, among others, the situation was not different as some motorists were seen in tears over the new pump price of N670.

They, however, called on President Tinubu to ensure Nigerians are safe instead of the terrible hardship currently being faced with.

A lawyer, Barrister Friday Osakpanmwan Ogieriakhi who spoke to journalists, said: "This is APC again causing unnecessary hardship after Buhari. It's a shame that Nigerians are back again in suffering with Tinubu who assured that he will move Nigeria forward. Now, where are we for a litre to sell for N670? It is preposterous; however. Nigerians, say no to this current situation of insecurity, hardship."

Residents have resorted to tricking long distances as a temporary solution to the current pump price increase.

Lamentations everywhere in Port Harcourt as fuel price skyrockets

Rivers State

In Port Harcourt, the Rivers Satte capital, petrol price yesterday was jerked up from N540 a litre to N680 in some filling stations and up to N710 in others.

Daily Times correspondent who monitored the price situation met angry faces at filling stations in Port Harcourt, most expressing shock over the development.

A consumer at a Conoil Filling Station along Aba Road, who gave his name simply as Chijioke, told Daily Times that he had been to two stations, but left because they were selling at "unimaginable prices" of between N710 and N730 per

litre, but bought at N680 per litre from Conoil.

He said: "The news of the price increase jolted me. We were still trying to adjust to N540 per litre, now this. I have been to three filling stations before discovering that Conoil was selling at a better price. This is just unfair to the suffering masses of this country who are going through hell to put body and soul together."

In his own response, another customer at one of the filling stations at Ikwerre Road, Port Harcourt, described the situation as "extremely bad".

According to him: "I bought fuel now from this filling station at N710. Can you believe that N4, 000 fuel managed to take my fuel gauge out of the red line. This is bad, unbearable.

"At this rate, these people are pushing the masses to the wall. How can we survive in this country with this? How can anybody blame those young people running away from this chaotic situation to foreign lands?"

It was observed that most filling stations were virtually empty and customers seen around were making very little purchas.

In Akwa Ibom, price of petrol rose to N600 per litre yesterday, leaving motorists and commuters in distress.

Most filling stations had earlier sold the product for between N515 and N550 before the latest hike.

However, shortly after the NNPCL announcement of price increase at about 1pm, motorists who tried to buy the product were shocked that the price per litre had gone up to N600. As of press time, several motorists were found parking their cars at roadside while pedestrians trekked long distances.

adding that fuel importers are gradually gaining confidence in the system.

Kyari said: "I don't have the details this moment. But we have the marketing wing of our company. They adjust prices depending on the market realities.

"This is really what is happening; this is the meaning of making sure that market regulates itself so that prices will go up and sometimes they will come down. This is what we have seen, and in reality, this is how the market works.

"There is no supply issue completely. When you go to the market, you buy the product; you come to the market, and you sell it at the prevailing market prices. There is nothing to do with supply shortage. We don't have supply issues. There is a robust supply. We have over 32 days of supply in the country.

"Yes, what I know is that the market forces will requlate the market. Prices will go down sometimes; sometimes it will go up. But there will be stability of supply and I am also assuring Nigerians that this is the best way to go forward so that we can adjust prices when market forces come to play.

"I don't have the details this moment, but I know that our marketing wing acts just like every other company in this business. I know that a number of companies have imported petroleum products today. So, many of them are on line. I'm sure my colleague would confirm this. Market forces have started to play; people have started having confidence in the market. Private sector people are importing products, but there is no way they can recover their cost if they cannot take market-reflec-

Corroborating the NNP-CL Chief Executive, Farouk Ahmed, CEO, Nigerian Mainstream and Downstream

Petroleum Regulatory Authority (NMDPRA) debunked insinuations that the new price adjustment was set by NNPCL.

Ahmed declared: "As a regulator, I told you back in May that we are not going to be setting price. The market will determine itself and as you saw back in early June when prices came out, it was based on the cost of importation plus other logistics of distribution and, of course, the profit margin by the importer. This market is deregulated; it is open to all participants.


"As I mentioned yesterday when I was in Lagos, we have about 56 marketing companies that applied and obtained licenses to import. Out of those, 10 of them have indicated to supply within the third quarter, which is July, August, September.

"Already, we received some cargoes from these marketers: Prudent Energy, AYM Shafa and Emadeb. Emadeb Cargo is arriving tomorrow. So, this is just an encouragement to see that the market is liberated, and everyone is free to import so long as you are working within the framework, especially in terms of quality. But on pricing, as a regulator, we are not going to put a cap on the price because we are not part of those importing. We are not a marketing company; we are just a regulator.

"So, when you say market forces are working, basically what it is that you buy; you consider the price of crude going up. A couple of weeks ago, the price of crude was hovering around \$70/barrel.

"Now it's hovering around \$80/barrel. So, the crude price also drives the product price. You know, because the importers are importing, they are basing it on the cost of importation plus the freight and other cost elements in terms of local distribution".

Mrs. Tinubu commended the Director General (DG) of the Center, Hajia Asabe Bashir and her management staff for taking the bold step towards the renaming of the center and also all the female National Assembly members who played leading roles in the legislative struggle for the renaming.

In his remarks at the event, the representatives of the Babangida family and sons of the late former First Lady, Mohammed Babangida, and his brother, Aminu, thanked the First Lady for the honor done their late mother.

Mohammed extended the appreciation to all the women who were contributory to the actualization of the renaming of the center.

Reps to probe I50,000mts stolen crude oil, burnt vessel

Moving the motion, Ereyitomi noted the recent reports of interception, arrest and subsequent destruction of vessels laden with stolen crude oil in the Niger Delta region, the most recent being MT TURA II on Friday, July 17 2023 in the escravos river in Warri South-West Local Government Area, Delta

He also noted that the vessel, an 800,000-tonne capacity one, was at the time of arrest and destruction, laden with about 150,000 metric tonnes of stolen crude oil.

The lawmaker said the vessel was set ablaze by a joint team of Nigeria security forces and representatives of the NNPC Ltd. on July 11, 2023, adding that in October 2022, a vessel named MT DEIMA which was laden with 1500 metric tonnes of stolen crude oil, was also arrested and set ablaze in the Warri Escravos river.

Ereyitomi said the House was: "Also aware that setting ablaze stolen crude oil laden vessels will further destroy the well-endowed ecosystem of the Niger Delta region already ravaged by oil exploration.

"Worried that this act if allowed to continue, will further affect the livelihood and the overall well-being

of the Niger Delta people who have fishing as their main occupation.

"Cognizance of the determination of the Federal Government to curb oil spill in the Niger Delta region and make the living condition of the people better."

Adopting the motion, the House mandated the Committees on Environment and Maritime (when constituted) to ensure compliance.

overnor Douye Diri of Bayelsa State has awarded a N40million research grant to Professor Dimie Ogoina, an indigene of the State who is also named among the Time Magazine 2023 100 Most Influential Persons in the World.

Diri made the pronouncement when Prof. Ogoina, accompanied by members of the central planning committee for celebrating the recipient, paid him a courtesy visit in Government House, Yenagoa, the State capital.

Governor Diri, who applauded Ogoina for his dedication to duty, noted that the Chief Medical Director (CMD) of Niger Delta University (NDU) Teaching Hospital, Okolobiri, in the State was instrumental to the reduced number of deaths recorded in Bayelsa during the COVID-19 pandemic that ravaged the world in 2020.


In their contributions, the lawmakers unanimously lauded the governor's decision to appoint the special advisers.



Fuel Subsidy Removal: a Bumpy Road Ahead for Nigerians

s fuel prices continue to soar, the question of where Nigerians can travel to within their limited means looms large. The removal of fuel subsidy, though touted as a necessary step, has unleashed a chain reaction of hardship that is felt deeply by the citizens. The government's promises of relief, while offering a glimmer of hope, fail to provide immediate respite.

The Fallout

In a bold move that sent shockwaves throughout Nig-

eria, President Bola Ahmed Tinubu, upon his inauguration on May 29th, announced the long-awaited removal of fuel subsidy. This decision, met with mixed reactions, has set in motion a series of events that have left Nigerians grappling with the harsh realities of escalating fuel prices and its far-reaching consequences.

Since the removal of fuel subsidy, the nation has witnessed a flurry of travel problems that have adversely affected the lives of ordinary Nigerians. The recent announcement of yet another fuel price hike, with petrol now soaring to an astonishing N617 per litre, has only exacerbated the situation. The affordability of travel has become a distant dream, and Nigerians are left wondering where they can venture to, given their limited financial means.

The Domino Effect

The removal of fuel subsidy has caused a ripple effect across the nation, permeating various aspects of everyday life. As petrol prices skyrocket, the prices of goods and services have followed

As Nigerians grapple with the harsh realities of their pockets being stretched beyond their means, they are left wondering when they will see light at the end of this bumpy road.

ood prices have skyrocketed, and nothing is cheaply affordable to satisfy the venomous hunger in the land.

One can wonder how the price of sweet potatoes became unbearable.

A portion for N200 after two months is now N1, 000; maize flour jerked up to N1, 000. In fact, all food items' prices have jerked up --and keep soaring.

As hunger is crushing Nigerians to death and the Federal Government is implementing the sharing formula of the N819bn supplementary budget for palliatives, Nigerians groan as National Assembly (NASS) takes the lion share of the money, while 12 million Nigerians get N8, 000 for six months.

The prices of foodstuffs soar and people suffer after the subsidy removal. Youth Corps members posted to

various states to serve the country are suffocating in hunger as N33,000 monthly stipend cannot afford their transportation and feeding with the current inflation index.

While NASS is sharing the palliative money, nothing is been said of the welfare of Youth Corps members that dedicate their strength and vigor to serve the nation. 400,000 Youth Corps members are annually posted to various states outside their native areas to serve the people and the nation.

Therefore, as almost unemployed persons, they need succor at this time of economic hardship to survive, and their situation should be considered.

In a response to a question on the sharing formula of the N12 billion-forthe-masses palliative, the National Social Safety Nets Coordinating Office (NASSCO) didn't mention Corps members among beneficiaries of the palliatives.

It is not only the Youth Corps members that face the hardship of the time, but the masses also do, as the present hunger hunts to kill Nigerians:

How painful could this be when a father is crowded by his wife and three children and the second child of three said to the father: "Daddy, I am hungry, I need food... I will die of hunger."

And the helpless father

burst into tears. Without uttering a word, he sluggishly went outside the room, staggering and weeping profusely like a baby. This is a true story.

For a bitter truth; Nigerians are living a hellish life presently. They helplessly watch their loved ones die of disease because of poverty and hunger occasioned by the fuel subsidy removal.

Many families, even children of tender age, now eat just once a day. Poverty has taken over the affairs of Nigerians as we surrendered to its wickedness.

Nothing is easy and cheaply accessible in Nigeria; life has become unbearable and very expensive.

Only few are exempt from the heat of the moment after the subsidy removal. Civil servants have become the true servants of hunger; marketers and traders are eating even their capital.

Almost all Nigerians are living a deficit life. Inflation is trending while schools have become expensive for students to bear. People now give collateral of their goods, items and working tools to collect food for their families.

Marriage has become flexible because of poverty and hunger among beloved couples.

Hunger has destroyed hope, ambitions have become empty and Nigerians' visions lie on survival. Poverty has become

the devil among the saints; while poverty gives birth to crimes and criminals, life is becoming tougher and suffocating. How can maximum security be achievable in this doom time of banditry, kidnapping and insurgency?

Subsidy removal, even though good for Nigeria but the effects are devastating because no pre-measures were taken to address its post-challenges.

While Nigerians are in abject poverty, with most unable to eat three meals a day, but the National Assembly members did not change to sacrifice anything for Nigeria's development amidst the fuel subsidy hardship.

In just less than two months, the 469 National Assembly members proposed 140% salary, N70 billion palliatives, proposed N40billion for cars, N24billion for accommodation, N110billion allowances for wardrobe, newspapers, kitchen and travelling, domestic staff -all for themselves!

Even though NASS got N328.1billion in the 2023 budget and routinely collect the highest salary than all government workers in Nigeria, yet they always seek and ask for more. While the 469 National Assembly members are voted to represent the voters, they argue most about their interests and represent themselves than the citizens.

But, if the National Assembly members and the President should prioritize the voters' interests and work accordingly, there will be no political thuggery, political dogs, political beggars, political warfare and zero venomous hunger in the land. Unfortunately, politicians can do anything to get power for unlimited favors.

With many suggestions from people on how the Government should share the palliative fund to ease the difficult experiences in the lives of Nigerians, the government should consider the three most important areas of human life: agriculture, education and health.

Increasing cases of drug abuse among Nigerian youths

espite the campaign against drug abuse by government at all levels, non-governmental organisations and individuals, and particularly the National Drug Law Enforcement Agency (NDLEA), Nigerian youths are getting neck deeper into the vice.

The devastating consequences of drug use know no geographic, economic, social, or ethnic boundaries. Each year, hundreds of thousands of people around the globe - rich, poor, educated, illiterate, male, female, and even young children die from drug abuse, and millions more are victims of addiction and drug-fueled violence.

Beyond the toll drugs take on health and welfare, substance use disorders undermine economic development, diminish social and political stability, and reduce security in countries and regions around

It is no longer news that a greater percentage of youths in Nigeria today get themselves involved in one form of drug abuse or the other.

Amidst the widespread commendations over the ban of codeine and tramadol by the Federal Government, a new large-scale nationwide survey has revealed that drug use by people within the ages of 15 and 64 years in Nigeria is on the rise.

A survey on drug use in Nigeria not long ago revealed that the nation is breeding a wild generation of drug addicts. This gory state of affairs of substance abuse calls for the declaration of a state of emergency, considering the fact that the youth population is the fulcrum of national development.

The 2018 National Drug Use Survey, a joint research by the National Bureau of Statistics (NBS) and the Centre for Research and Information on Substance Abuse (CRISA) with technical support from the UNODC, gave a damning account of rising drug use in Nigeria, noting that as of the time of the research, 14.3 million Nigerians aged between 15 and 64 years engaged in drug use.

Of this figure, the survey added that about three million were drug dependent and suffering from substance-induced disorders

Another nationwide survey by the United Nations Office on Drug and Crime (UNODC) funded by European Union (EU) in partnership with the Federal Government said no fewer than 10.6 million Nigerians abused cannabis in 2018, while 4.6 million abused opium.

The report said that 2.4 million youths and adults also abused cough syrups with 92,000 more using cocaine. Other drugs commonly abused during the period are tranquilizers and sedatives, solvent, inhalers, amphetamines and prescription stimulants.

This survey also reports that one of four drug users in Nigeria is a woman. Adding that the extent of drug use in Nigeria is comparatively high compared to previous global annual prevalence of any drug abuse

Basically, youths in the country inhale, inject and consume psychotic and narcotic substances and drugs at will, easily evading the scrutiny of a society distracted by economic malaise at the expense of their

future wellbeing.

Truth be told, the impact of drug abuse is lethal. Many families are contending with drug addicts; some of them have quit schooling and work; others are on the verge of lunacy or battling with acute diseases.

The number of drug users in Nigeria is estimated at 14.4 per cent or 14.3 million people aged between 15 and 64 years according to the results of the National Drug Use Survey. The data suggests that the prevalence of drug use in Nigeria is more than twice the global average of 5.6 per cent.

The extent of drug use in Nigeria is comparatively high when compared with the 2016 global annual prevalence of any drug use of 5.6 per cent among the adult population.

There is a gap in meeting the needs for treatment and care for people with drug use disorders. With close to three million Nigerians living with some level of drug dependence, the extremely limited availability of drug counselling and treatment services exacerbates this health crisis.

This is indeed striking and alarming and calls for concerted efforts to mitigate the negative consequences of this rising menace on the health, socio-economic and security of our nation.

Even though the Federal Government has over the years responded boldly to this global challenge with innovative, standard-setting drug demand reduction programmes, we are of the opinion that there is need to solve the problem.

Awareness programmes need to be developed to address the perception of stigma among the youth and their families over substance use and to remove barriers towards seeking care for these problems.

These programmes should also address the inability of the youth to perceive addictive behaviours as a health risk.

Parents and support persons' involvement and engagement in youth programmes should be strengthened further as it improves communication and better decision-making for youth health issues.

Family-based prevention programmes emphasising parenting skills, training or improving family functioning, communication and family rules regarding substance abuse needs to be introduced.

Also, teachers are a major source of information to young people. Hence, strengthening the role and performance of educational institutions, ensuring availability of counselling services, gender sensitivity issues, making life skills courses a part of curriculum are required for health and welfare of young people.

Most importantly, in all youth related programmes, young people should be involved and engaged to empower them to make informed decisions.

Akwa State police avert mob action on two suspected thieves

ossible death awaited two suspected thieves who allegedly stole two bottles of Campari drink and an electricity generating set from different towns in Akwa Ibom State had the police not stepped into the matter and rescued them from irate mobs.

In a statement issued in Uyo, the State capital, yesterday, the state Police Public Relations Officer (PPRO), Superintendent (SP) Odiko Mcdon, said one of the suspects, identified as Ubong Sunny Ossom, was caught allegedly stealing the drinks at a supermarket in Ekpene Ukim, Uruan Local Government Area (LGA).

Mcdon disclosed that the other suspect, whose name he gave as Christian Effiong, was caught allegedly stealing the generator from a church in Ikot Ambon, Ibesikpo Asutan LGA.

He said the two were rescued as angry crowds, which first held them, were on the verge of setting them

"One Ubong Sunny Ossom, 'm', of Ikot Edebe village in Nsit Atai LGA who stole 2 bottles of Campari at Godslight Supermarket, Ekpene Ukim, in Uruan LGA and one Christian Effiong, 'm' ,of Nung Atai okobo village in Okobo LGA who stole a generator at Mount Zion Church, Ikot Ambon in Ibesikpo Asutan LGA, were both rescued at the verge

of being burnt after they were caught for stealing. This trend is becoming too frequent and alarming," the PPRO said.

Mcdon who decried the wave of jungle justice in the state, condemned mob action that sent alleged victims to their early graves.

"While the (state Police) Command condemns in

totality the act of stealing, which is a crime, subjecting the perpetrators to jungle justice is not in tandem with our legal system.," he

He said the state Commissioner of Police, Olatoye Durusinmi, has warned perpetrators of jungle justice to desist from such acts as they would be arrested and pros-



Police officer who filed charges against Oduah not our staff, EFCC tells court

conomic and Financial Crimes Commission (EFFC) yesterday denounced a police officer who filed an eight- count criminal charges against former Minister of Aviation, Senator Stella Oduah at the Federal High Court In Abuja, as an ex-staff.

EFCC lawyer H.A.Okonfua told the Federal High Court that the police officer, Ibrahim Mohammed, who filed the charge, was no longer a staff of the anti-graft agency.

She said that EFCC had investigated the source and authenticity of the charge as directed by the court and found that the person who signed it (Ibrahim Mohammed) was redeployed to Police Forces Headquarters on November 4, 2022.

He signed the charge on June 22, 2023, as a staff of EFCC and is prosecuting the case himself seven months after his exit from the commission.

Okonfua further told the court that the detailed report of EFCC's investigation has been filed at the court

Justice James Omotosho said that since the report is not yet in his file, he will adjourn the matter to October

It is recalled that Tuesday last week, a prosecuting police officer had caused suspicion in court when he appeared as EFCC lawyer trying to arraign Oduah on the eight-count charge.

Trial court judge, Omotosho suspected foul play when he noticed that a police officer who claimed he has been redeployed from EFCC to Legal Department, Force Headquarters since November 4, 2022, was still appearing for EFCC in the matter.

A mild drama then ensued in the court room that cumulated in Justice Omotoso ordering investigation of the said prosecution counsel (Ibrahim Mohammed) who filed the charge against Oduah.

The judge ruled that, "in view of the fact that Ibrahim Mohammed signed this charge on June 22, 2023 and having admitted himself to have left EFCC in Novem-

ber 2022, this court makes an order directing EFCC to investigate and report back. Counsel in company with police shall report to EFCC immediately.'

Ovo fixes date for 2023 common entrance examinations

Tinubu to review N8000 palliative as NLC berates FG on 'deceit' of Nigerians

resident Bola Tinubu has ordered the immediate review of the proposed N8,000 cash transfer to help cushion the effect of the fuel subsidy removal.

According to a statement signed by the Special Adviser to the President on Special Duties, Communications and Strategy, Dele Alake, the order follows series of commentaries from Nigerians on the Federal Government's planned action.

Alake said that the President, being a listening leader who has vowed to always put Nigerians at the heart of his policy and programmes, has emplaced a broad spectrum of reliefs to bring help to Nigerians.

He assured Nigerians that the N500 billion approved by parliament to cushion the pain occasioned by the end of subsidy regime will be judiciously utilised.

Furthermore, he also promised that the beneficiaries of the reliefs shall be Nigerians, irrespective of their ethnic, religious or political affiliation.

The statement said: "You will agree with me that it has become part of the culture of President Bola Ahmed Tinubu administration to constantly dialogue with Nigerians who voted him into

"The President covenanted with Nigerians that their welfare and security will be topmost in the Renewed Hope Agenda of his govern-

"In the last few days, the conventional and

new media platforms have become awash with stories of the government intending to embark on conditional cash transfer to vulnerable households mostly affected by the painful but necessary decision to remove subsidy from petrol.

"The story has been widely reported that the Federal Government is proposing to give 12 million households from the poorest of the poor N8,000 monthly for a period of six months as government palliative to reduce the discomfort being experienced by Nigerians consequent upon subsidy removal.

"A lot of ill-informed imputations have been read into the programme by not a few naysayers. The Administration believes in the maxim that 'when there is prohibition, there must be provision'. Since subsidy, the hydra-headed monster threatening to kill the economy, has been stopped, government has emplaced a broad spectrum of reliefs to bring help to Nigerians.

"While it should be noted that cash programme is not the only item in the whole gamut of relief package of President Bola Ahmed Tinubu, as a listening leader who has vowed to always put Nigerians at the heart of his policy and programme, the President has directed as follows: That the N8,000 conditional cash transfer programmed envisaged to bring succour to most vulnerable households be reviewed immediately. This is in deference to



the views expressed by Nigerians against it.

That the whole gamut of palliative package of government be unveiled to Nigerians.

"Immediate release of fertilizers and grains to approximately 50 million farmers and households respectively in all the 36 states and the FCT.

'The President further assures Nigerians that the N500 billion approved by parliament to cushion the pain occasioned by the end of subsidy regime will be judiciously utilized. The beneficiaries of the reliefs shall be Nigerians irrespective of their ethnic, religious or political affiliation.

'President Bola Tinubu has promised to always prioritize the wellbeing of Nigerians and he is irrevocably committed to the vow. A number of decisions taken so far by this Administration have buttressed this stance.

'You will recall that the President took a similar decision after listening to complaints from the business community/ stakeholders about burdensome taxes, particularly multiplicity of taxes they are made to experience. This warranted the signing of four (4) Executive Orders cancelling some classes of taxes, while suspending the implementation dates of others.

'In addition, the President has also set up a Tax Reform/Fiscal Policy Committee to bring up recommendations that will engender a wholesome fiscal environment for the country and remove anti-business bar-

"I wish to assure Nigerians that President Tinubu will continue to be a listening leader whose ears will not be dull to the views expressed by the citizenry. The President believes government exists to cater for the interest of the people and he has demonstrated this so clearly."

Meanwhile, Nigeria Labour Congress (NLC), yesterday condemned the Federal Government's plans to share N8,000 to 12 million poor households as palliative to cushion the effect of fuel subsidy removal.

In a statement, NLC President, Comrade Joe Ajaero, also kicked against the Federal Government's move to pay National Assembly members N70 billion and the Judiciary N36 billion, describing it as the most "insensitive, reckless and brazen diversion of our collective patrimony into the pockets of public officers whose sworn responsibility it is to protect our nation's treasury."

Ajaero, while describing the move as hush money and outright bribery of the other arms of government to acquiesce the aberration to spend N500 billion on palliatives, said NLC does not have confidence on how the data for the "never changing 12 million poorest households was generated, nor do we have confidence in the mechanisms being pursued for the distribution of the cash transfers."

The statement read: "It is on this basis that the NLC strongly condemns the decision of the Tinubu-led administration to seek the approval of the National Assembly to obtain another tranche of external loans worth N500 billion from the World Bank for the purposes of carrying out a phantom palliative measure to cushion the effect of its poorly thought-out hike in the prices of Premium Motor Spirit. Remember that the U\$800 million which was already proposed before the devaluation of the Naira by this government was worth about N400 billion then but is now worth about N650 billion after devaluation. It is from this, it proposes to bring out N500 billion for distribution.

The proposal to pay N8,000 to each of the socalled 12 million poorest Nigerian households for a period of six months insults our collective intelligence and makes a mockery of our patience and abiding faith in social dialogue which the government may have alluded to, albeit pretentiously.

'The further proposal to pay National Assembly members the sum of N70 billion and the Judiciary N36 billion is the most insensitive, reckless and brazen diversion of our collective patrimony into the pockets of public officers whose sworn responsibility it is to protect our nation's treasury. We believe that this may amount to hush money and outright bribery of the other arms of government to acquiesce the aberration.

"It is unconscionable that a government that has foisted so much hardship on the people within nearly two months of coming into office will make a proposal that clearly rewards the rich in public office to the detriment of the poor. What this means all this while is that the government is seeking ways of robbing the very poor Nigerians so that the rich can become richer.

"There is no other way to explain the proposal to pay a miserly sum of N8,000 to each of the mysterious poorest 12 million Households for six months which amounts to N48,000 and pay just 469 National Legislators N70 billion or about N149 million each while the Judiciary that has about 72 Appeal Court Judges, 33 National Industrial Court Judges, 75 Federal High Court Judges and 21 Supreme Court Judges and a total of about 201 Judges receives a total of N35 billion or N174 million each. If these other two arms are projected to receive this, what members of the Executive Council will receive is better left to the imagination of Nigerians perhaps, the balance N150 billion will go to them.

"These proposals are not just unacceptable to Nigerian workers but are also dictatorial thus undemocratic. It is not a product of social dialogue which would have produced collectively negotiated outcomes by critical national stakeholders. He accused Hon. Akpulonu of inciting members of the House against the leadership of the 8th Assembly, a situation the Speaker described as inimical to the growth and progress of the House in particular and the state in general.

The Speaker pointed out that it was absolutely wrong for the lawmaker to be granting press interviews and revealing all that the House has been doing, without proper clearance from the leadership of the House, insisting that what is done in the House should remain in the House.

Emeruwa said: "Hon. Akpulonu has been causing chaos in the Assembly since its inauguration and we have been tolerating for too long. As lawmakers, it is normal to disagree as long as it is done with decorum within the confines of the law."

The Speaker said even as Hon. Akpulonu was not present during plenary, his suspension will be communicated to him immediately.

It is recalled that the 11 Peoples Democratic Party (PDP) members in the 8th House of Assembly had staged several protests to the effect that the Majority Leader seat, among others, be given to the PDP, given they conceded the speakership and deputy speakership seats to Labour Party whose lawmakers are just 10 in the House.

However, the leadership of House went ahead to announce member for Arochukwu. Hon. Okoro Uchenna as Majority Leader of the House, which further angered the PDP members.

The Speaker has also failed to read out the PDP letter nominating its members for majority leadership position---an action which also led to another peaceful protest and the subsequent rowdy session during their last plenary on July 11, 2023.

Reps order FAAN to install specialized medical equipment at airports

ouse of Representatives has called on the Federal Airports Authority of Nigeria (FAAN) to put in place adequate medical facilities in the nations' airports to forestall sudden death from high blood pressure (HBP) and diabetes, among other ailments.

The House also urged the Ministries of Aviation and Health to collaborate with relevant healthcare professionals and organizations to establish and operate HBP and sugar levels check desks at airports and local clinics across the country.

It further asked that the desks be manned by trained healthcare personnel who can accurately measure blood pressure and sugar levels, provide basic counselling, and refer individuals to appropriate medical services, if necessary.

These resolutions were sequel to the amendment and adoption of a motion moved by Rep Kalejaiye Adeboye Paul (Lagos State) at plenary yesterday.

To avoid sudden deaths from high BP, diabetes, others



Moving the motion, Paul said air travel can be physically demanding and stressful for many passengers and these factors, combined with the potential health risks associated with long flights and varying environmental condi-

tions, make it essential to prioritize the health of individuals passing through our airports.

He noted that: "By establishing free High Blood Pressure and Sugar Levels Check Desks at all airports, we can promote early detection and preventive care for conditions such as hypertension and diabetes.

'Regular monitoring of these vital health parameters will enable travelers to seek medical intervention and prevent potential complications.

The provision of these check desks will demonstrate our commitment to public health promotion."

Adopting the motion, the House mandated its Committee on Aviation (when constituted) to ensure compliance.

Drama at Abuja Markets Management Ltd as two feud over MD position

here is palpable tension in Federal Capital Territory Administration (FCTA) as the sacked Managing Director (MD), Abuja Markets Management Limited (AMML), Alhaji Abubakar Faruk, yesterday locked out his successor, Engr. Abbas Yakubu, from the office,

Trouble started at AMML, one of FCTA's revenue-generating agencies, when Faruk stormed his former office accompanied by some police officers to lock out the new acting Managing Director, Engr. Yakubu.

The embattled Faruk was allegedly suspended by the immediate past FCT Minister, Malam Muhammad Bello, but he obtained a restraining court order and has been allegedly scheming to retain his appointment with the help of some powerful Northerners.

It was gathered that his argument was predicated on the fact that his appointment was not tenured and therefore, he cannot be removed from office ahead of his statutory exit date.

Notwithstanding these, Faruk's employment was terminated by Mr. Abubakar Maina on behalf of AMML's shareholders vide a letter dated July 17, 2023, and signed by him (Maina), as the Group Managing Director (GMD) of Abuja Investments Company Ltd (AICL), the supervising agency over AMML.

But fresh trouble erupted yesterday morning when the sacked Faruk stormed AM-ML's office, located in Gudu District of Abuja, with some police officers and locked the MD's office, insisting that nobody will access it and take possession of same.

It was learnt that following the chaos created by his action, the staff members have been apprehensive, not knowing what fate will befall them.

Staff members of AMML also complained that the cops that came with the sacked MD harassed and created serious psychological trauma for them.

While the FCTA authorities were yet to comment on the matter, the management staff of AMML has been summoned to Durumi Police station, Abuja, so stem any acts likely to cause breach of public peace.

Confirming the incident, AMML's Public Relations Officer, Innocent Amechina said: "He locked his own office. Yesterday, the shareholders of AMML decided to relieve him of his job as the MD, and it was made known to everybody. Surprisingly, that resolution was supposed to take effect from today. He came with four policemen, locked his office and also changed the lock.

"As I speak to you now, we are at the Durumi Police station, with both the sacked and new acting Managing Director, Engr. Abbas Yaku-

Radda raises committee to recruit 2,400 volunteers over insecurity

t least 2400 local security volunteer cadets will be recruited by the Katsina State Government to serve as official 'vigilantes' to beef up security all over the State.

Bandits and kidnappers have placed the North-West State under the cosh for years now, unleashing violence on a scale hitherto unknown in the State which prides itself as home of hospitality.

The cadets are to complement the efforts of regular, armed security agencies.

Governor Dikko Umaru Radda yesterday inaugurated an ad hoc committee for the recruitment.

The governor's Chief Press Secretary (CPS), Ibrahim Kaula Mohammed, who disclosed news of the committee inauguration, in a statement, said the committee, chaired by Maj. Gen. Junaidu Bindawa, a former General Officer Commanding (GOC), 7th Division, Nigerian Army, has eight weeks to submit its report to the State government.

Radda tasked the committee members to recruit the best from among youths in the State for the onerous assignment which seeks to boost security in eight Local Governments of Batsari, Jibia, Safana, Danmusa, Kankara, Sabuwa, Faskari and Dandume, sorely impacted by relentless terrorism.

Gov. Radda handed the committee its terms of reference, saying it has "the mandate of advising the government on how to systematize the payment of allowances and the purchase of equipment for the volunteered officers and as well determine whether it is appropriate to include vigilantes men in the scheme or otherwise.

"Furthermore, the committee would also suggest how these new officers should be given special training to carry out their duties properly in their respective communities.

"In addition, the committee would also advise on how to successfully kickstart the programme. It also has a free hand to bring in any community member whom they consider suitable for making the programme successful."

Deputy Director, Security, in the Governor's Office, Hamza Audi Kofar Bai, is to serve as the committee's secretary while members are retired Deputy Inspector General (DIG) of Pollice, Mai Gari Dikko, retired Air Vice Marshal (AVM) Sadiq S. Kaita (rtd), and Maj. Garba Mohammed Rimi (rtd).

"You know Papa started the Inter-Religious Council with the former Sultan of Sokoto and he was in good relationship with other Sultans of Sokoto. So these eminent leaders will come and honour him."

Mbang also disclosed that there would be a special service on Wednesday, 19 July 19, 2023 (today) by his alma mater, the Methodist Boys High School Old Boys, followed by a novelty football match between the Methodist Old Boys and



Hope Waddel Old Boys, at Shelter Afrique, Uyo.

"On Wednesday 26th July, 2023 a commendation service is slated to hold at the Methodist Church of the Trinity, Tinubu in Lagos by 10am.

"On Thursday 3rd August, 2023 there would be a special service to be conducted by the Christian Association of Nigeria, CAN, at the National Christian Centre, Abuja by 4pm," he added.

January 6 Probe: Trump says he expects indictment after target letter

onald Trump has said he expects to be arrested by a federal inquiry into the US Capitol riot and efforts to challenge the 2020 election results.

The ex-president said in a social media post he had been informed by special counsel Jack Smith on Sunday night that he was a target of their investigation.

Mr Trump posted that he was told to report to a grand jury, "which almost always means an Arrest and Indictment".

The special counsel did not immediately respond to media inquiries.

Such an indictment would be Mr Trump's third for alleged criminal offences, including 37 counts brought by Mr Smith's team in June accusing the president of mishandling classified doc-

Mr Trump has also been charged in New York City with falsifying business records in 2016 hush money payments to adult film star Stormy Daniels.

He is due to stand trial in that case next March, while a date for the classified documents case is still being contested by the president's

In a post on his Truth Social platform, Mr Trump claimed that he had been sent a letter "stating that I am a TARGET of the January 6th Grand Jury investigation, and giving me a very short 4 days to report to the Grand Jury, which almost always means an Arrest and Indict-



Mr Smith was appointed special counsel by US Attorney General Merrick Garland shortly after Mr Trump announced his presidential campaign last autumn.

His team was tasked with investigating Mr Trump's handling of classified documents after leaving the White House and of managing a sprawling federal investigation into the riot at the US Capitol and attempts by Mr Trump and his advisers to "interfere with the lawful transfer of power following the 2020 presidential election".

The special counsel's office has not discussed what specific criminal violations they are considering. It is not known if others have been told they are a target.

Last December, a House committee investigating the events of January 6 recommended four separate criminal charges be brought against the former president

and his associates:

The Democratic-led committee - which included two Republicans - described the criminal referrals as a "roadmap to justice", but prosecutors do not have to follow a congressional committee's recommendations.

Mr Smith's own investigation has involved interviews with dozens of top Trump administration officials and advisers, including former Vice-President Mike Pence and Trump lawyer Rudy Giuliani.

According to public comments by some who have testified before the grand jury, questions have focused on efforts by Mr Trump's team to organise slates of "fake electors" who would claim that the former president had defeated Democrat Joe Biden in seven key battleground states.

State prosecutors in Atlanta, Georgia, are also investigating the former president on similar grounds, focusing on whether he illegally pressured state officials there to discard Mr Biden's victory. In a December 2020 phone call with Georgia Secretary of State Brad Raffensperger, Mr Trump asked that Georgia officials "find 11,780 votes" that would flip the state to Mr Trump.

A decision by Georgia prosecutors on whether to indict Mr Trump is expected in August.

Mr Trump is currently the frontrunner for the 2024 Republican presidential nomination, with double-digit polling leads over his nearest rival, Florida Governor Ron DeSantis.

Speaking to CNN's Jake Tapper on Tuesday, Gov DeSantis suggested Mr Trump "could've come out more forcefully" to stop the Capitol riots but said he hopes the former president "doesn't get charged".

"I don't think it'll be good for the country. But at the same time I've got to focus on looking forward, and that's what we're gonna do," said Gov DeSantis.

Australia baffled as unidentified mystery object washes up on beach





olice have been baffled by a mysterious "unidentified" dome that washed up on a West Australian beach.

The giant metal object was found by locals at Green Head beach, about 250km (155 miles) north of Perth.

State and federal authorities are investigating the item, which is not currently believed to be from a commercial aircraft.

It is being treated as hazardous, and police have requested people keep a safe distance.

'We want to reassure the community that we are actively engaged in a collaborative effort with various State and Federal agencies to determine the object's origin and nature," police said in a statement.

These include the military and Australia's space agency.

Green Head beach residents said the cylinder was about 2.5m wide and between 2.5m and 3m long, Australia's public broadcaster reported.

Residents visited the site on Saturday night to see the cylinder, the ABC reported, with one local describing it as a "great social evening".

"It was a lovely, still night, the kids were digging sand castles around it," he told the ABC.

Aviation expert Geoffrey Thomas said the item was possibly a fuel tank from a rocket that had fallen into the Indian Ocean at some stage in the past 12 months.

The Australian Space Agency said it was possible the giant cylinder could have fallen from a "foreign space launch vehicle" and it would liaise with other international agencies.

If it is a fuel cylinder, experts believe it might be from an Indian rocket and could contain toxic materials.

It is hoped a serial or catalogue number will confirm whether or not this is the case.

There was some speculation the cylinder may have been a part of MH370 - a plane that went missing off the west Australian coast in 2014 with 239 passengers on board - but Mr Thomas said there was "no chance".

"It's not any part of a Boeing 777 and the fact is MH370 was lost nineand-a-half years ago so it would show a great deal more wear and tear on the debris," he said.

What happened to US citizens like Otto Warmbier detained in North Korea

ince the guns of the Korean War fell silent on 27 July 1953, tens of thousands of US troops have remained in South Korea to cast a wary eye across the 38th parallel to North Korea.

Together with their South Korean allies, US forces regularly conduct large-scale military drills on the peninsula, frequently drawing angry rebukes from Pyongyang's government.

But despite these tensions and a lack of formal diplomatic relations between the US and North Korea, a small but steady stream of Americans have visited the country on organised tours - sometimes with dangerous results.

"Do not travel to North Korea due to the continuing serious risk of arrest and long-term detention of US nationals," reads a sternly worded travel warning on the US State Department's website. "The US government is unable to provide emergency services to US citizens in North Korea."



US citizens have been detained in North Korea several times since 1996, including tourists, scholars and journalists.

In July 2017, the US government banned US citizens from visiting the country - a move that has since been extended until at least August this year.

Here are some of the most notable cases from the last decade.

Otto Warmbier, a student at the University of Virginia, was arrested while visiting North Korea as part of a tour group in January 2016. The visit, organised by a China-based budget tour operator that specialises in off-the-beaten-track destinations, was a five-day trip to experience North Korea during the New Year's Eve

period. His father later told the Washington Post that he was "curious about their culture" and "wanted to meet the people of North Korea".

About two months after his detention on 2 January, a North Korean court sentenced Otto Warmbier to 15 years' imprisonment with hard labour on charges that he attempted to steal a propaganda poster.

Erosion: Senate raises the alarm, wants FG to address menace in Edo, Anambra

oncerned about havoc wrecked by ■devastating erosion that is ravaging communities in Edo and Anambra the Senate, on Tuesday, charged the Federal Government to urgently address the live threatening menace.

This was consequent upon deliberations by Senators during plenary on three separate motions which centred on erosion.

Senator Monday Okpebholo, (Edo Central) senatorial district, in his motion tagged "Urgent Need for Erosion Control in Edo Central Senatorial District to Save Lives and Properties", lamented that occasional flooding has subjected many communities to constant threat of devastating erosion which

has kept many roads impassable.

He said: "the Okene-Auchi-Benin expressway, a major road infrastructure in Nigeria began to fail at the Ekpoma axis owing to several gully erosions. The Ewu-Uromi-Agbor Road corridor has also experienced similar fate in Uromi axis. Nigerians in Irrua, Ekpoma, Uromi, Ewu and other communities have fled their homes or got their access roads damaged owing to the erosion problems.

"In June, two persons died after being swept away from their homes in Ujoelen, Ekpoma. A school girl died two years ago in Efandion, Uromi, on her way to school due to the uncontrollable flooding. It is difficult to construct roads to Udo community because of the wild erosion gullies. This trend is all over the

projects in Edo central face the risk of being damaged even before they are completed, as a result of which the country may just be losing hundreds of millions of naira because of the natural disaster. The cost of interventions in erosion disaster is too weighty for local and state governments to bear.

"We urge for the collaboration of federal agencies, namely; the Federal Ministry of Environment, Ecological Fund Office and the Federal Ministry of Works and Housing towards tackling the menace of erosion devastation in Edo Central Senatorial District

"We also urge the Federal Roads Maintenance Agency, FERMA, and the National Emergency Management Agency (NEMA) to collaborate and carry out emergency works on Ekpoma (Uhiele, Ujoelen, Ukpenu, Borehole Road & Emuhi), Irrua (Uwesan and

Ikekato), Ewu (Eguare and Uzogholo), Uromi (Efandion, Eguare & Uzegwa), Udo and Illushi."

Also, Senator Victor Umeh, (Anambra Central) senatorial district, in his motion, tagged "Urgent Need to Control the Erosion Ravaging Onitsha-Oba Section of the Onitsha-Owerri Federal Highway in Anambra State," said there is urgent need to addressed the issue to save life.

He said: "we note with dismay the devastating effects of ravaging gully erosion and landslide on Onitsha-Owerri Federal Road, between Electrical Parts Market and Metallurgical Training Institute, Obosi (Idemili North L.G.A) and Oba Junction near Rojenny Games Village in Idemili South L.G.A - along Onitsha-Owerri Federal Highway, all within Anambra Central Senatorial District of Anambra State.

Senate to investigate N6.5 billion NDDC ocean surge contract

enate on Tuesday unanimously voted to conduct an investigation into the N6.5 billionshoreline protection contract awarded by the Niger Delta Development Commission (NDDC) with a view to finding an alternative solution where necessary, to stem the incessant ravaging ocean surge in Ayetoro community in Ondo State.

This was sequel to a motion on "Urgent need for intervention to arrest the incessant Sea incursion ravaging Ayetoro community in Ondo state" sponsored by Senator Jimoh, Ibrahim (Ondo South).

He noted that the oil producing Ayetoro is a phenomenal historical and cultural settlement along the coastal stretch of Ilaje Local Government Area of Ondo State and is also a major source of revenue for the

"Avetoro community and its environs account for 5.4% of the 60,000 barrel per day of Ondo State's crude oil production output amounting to about 3.7% of Nigeria's total oil production and this ranks Ondo State as the 5th among Nigeria's oil producing States, under the Niger Delta Development Commission (NDDC) Act.," he said.

In presenting the motion, he complained bitterly that all is not well in Ayetoro as there are concerns of human insecurity, noting that the issue has caused several damages in the community.

"Ayetoro Community used to be one of the most prosperous riverine settlements in Nigeria due to its thriving trade in fish", Ibrahim added.

Stressing that the residents in the community are gradually losing hope, he worried that if nothing is done urgently, the community will be at the verge of being completely lost to the

"The devastating sea incursions and ocean surges have been the albatross of the Avetoro Community for over two decades with hundreds of homes and properties being destroyed annually resulting to displacement of indigenes of the community and consequently in the disruption of oil exploration in the area", he

The surges have become an annual occurrence that successive governments have failed to attend to and serving a daily reminder to the indigenes of Ayetoro that the community is gradually slipping into the belly of the Atlantic Ocean."

He further said that, "The Niger Delta Development Commission (NDDC) as early as 2004, just four years after its creation made commendable attempt to stem the tide by awarding the contract for the construction of a shoreline protective wall designed with a geotube technology in Ayetoro to Gallet Nigeria Limited at an original contract sum of N6.4 billion of which 25 per cent was reportedly paid.

The contract was revoked in 2009 for alleged lack of capacity and rewarded to Dredging Atlantic Limited at an undisclosed cost, however eleven years after the new contractor took over, abd sixteen years after the contract was first awarded,

there is nothing on ground to show any intervention by the government, thereby creating the wrong impression of ab unconcerned Federal Government."

In supporting the motion, Senator Abdul Ahmed Ningi (PDP, Bauchi Central) said it is a matter of urgency for the Senate to come to the aid of Ayetoro and come up with possible solutions.

Other senators who supported this motion are, Gbenga Daniel (APC, Ogun East) and Deputy Senate President, Barau Jibrin.



Terrorism is a social problem, it thrives where social control measures are weak, the people must get fully involved in intelligence gathering"

He asked rhetorically what has become of the local force, the Civilian joint military task force that provided the needed local support for the military especially in Borno

He urged the service chiefs to resuscitate it, as there is no two ways about it.

"Government at all levels must as a matter of adequste collaboration provide social safety nets particularly employment opportunities for the youth who are usually their targets so at to dissuade them from being lured into these clandestine activities.

"When terrorists are denied or starved of fertile ground for recruitment their



existence begins to fizzle out naturally, this can only happen when the citizens are cartered for. The Kinetic and None Kinetic approach must be deployed simultaneously, community involvement should be an integral part of this renewed war against insecurity, it has come to a point where the role of traditional and religious leaders must be reviewed and made more

However, a total of 868.80 million shares valued at N42.81 billion were exchanged in 8,970 deals. FCMB (+3.33%) led the volume chart with 153.88million units traded while DANGCEM (+6.67%) led the value chart in deals worth N35.81billion.

Also, market breadth closed positive at a 2.79 to-1 ratio with advancing issues outnumbering declining ones.

It is worthy of note that HONY-FLOUR (+10.00%) topped 38 others on the leader's table, while JAPAUL-GOLD (-10.00%) led 13 others on the laggard's log.

Oil rebounds on China's fiscal stimulus

il prices posted limited increases on Tuesday over hopes that the Chinese government will unveil fiscal stimulus measures to jumpstart the sluggish economy, as the country faces multiple post-pandemic economic headwinds.

International benchmark Brent crude traded at \$78.56 per barrel, translating to a 0.07% gain from the closing price of \$78.50 a barrel in the previous trading session on Monday.

The American benchmark West Texas Intermediate (WTI) traded at the same time at \$74.18 per barrel, up 0.13% from the previous session's close of \$74.08 per barrel.

The gross domestic product of China, the world's largest oil-importing country, fell short of expectations, declining by around 1.7% during the previous session due to disappointing economic data.

However, investors are now looking at the country's mitigation measures to stimulate its floundering economy.

Supporting the upward movement of dollar-indexed oil prices, the value of the US dollar showed a 0.17% decline against a basket of currencies, including the Japanese yen, British pound, Canadian dollar, Swedish krona and Swiss franc.

Investors are monitoring the data flow from major economies, including the US, ahead of the

Federal Open Market Committee (FOMC) meeting on July 25-26.

The American Petroleum Institute (API) will issue forecasts of the newest data on the country's crude oil stockpiles later on Tuesday, while the US Energy Information Administration (EIA) will reveal the actual data on Wednesday.

The decline in crude oil stocks indicates improved demand in the US, which should push prices higher, whereas expanding stockpiles tend to force prices down.

Oil prices fell on Monday as China's weaker-than-expected economic growth projected a sluggish economic revival in the world's top crude oil importer, raising concerns over its oil demand.

According to China's National Bureau of Statistics, the country's economy expanded by 6.3% in the second quarter from a year earlier, falling short of predictions of 6.9%.

Although China's gross domestic product surpassed the 4.5% rise in the first quarter, the data overshadowed hopes of recovering demand to put downward pressure on prices.

Oil prices posted a limited increase of 4% last week over fears of tight supply driven by Saudi output cuts, and hopes of increased demand in the world's largest oil consumer, the US.

Wema Bank lifts suspension on international transaction on naira cards

igerian lender, Wema Bank, has lifted its suspension of international transactions on naira cards.

This means customers using the bank mastercard card now use their naira debit cards to pay for transactions originated in foreign currency.

The bank in a letter addressed to its customers announced the end of the suspension on international transactions conducted through naira cards.

This means customers using the bank mastercard can now use their naira debit cards to pay for transactions done in foreign currency.

In March 2022, the bank had joined other Nigerian banks to limit their monthly international spending limit on naira cards from \$100 to either \$20 or \$50.

Subsequently, in September, the banks said that naira cards would no longer be used for international

transactions, adding that the decision was due to market realities on foreign exchange.

Wema Bank went a step further to end cross-border payments with Naira cards in March.

The bank also had a \$500 monthly limit on international spending conducted through its naira cards.

"You can now use your Naira cards, including Mastercard, ALAT Mastercard, and Visa, for international spending. For your international transactions, you can enjoy up to \$500 per month," the bank said in a notice this week.

"Here's what you need to know: Expanded Possibilities: The Naira card allows you the freedom to make international purchases, explore international online stores, and buy from your favourite international brands. You know what? The world is now at your finger-

"Monthly Limit: To provide you

with enhanced security and control, there is a \$500 monthly spending limit for international transactions. This allows you to manage your expenses responsibly while enjoying the benefits of international spending.

"Effortless Convenience: Your Naira card gives you the convenience of making payments in foreign currencies, eliminating the need for currency conversion or carrying excess cash. It's a hassle-free and secure way to shop and transact abroad."

The new development comes against the backdrop of President Bola Tinubu's efforts to unify the nation's multiple exchange rates as part of measures to attract investors into the economy.

The Central Bank of Nigeria had on 14 June announced the unification of all segments of the Nigerian forex market, collapsing all windows into the Investors & Exporters (I&E) window.

Contaminated fuel: UNA boss calls for audit of aviation fuel suppliers

n the light of recent incident of fuel contamination that led to the suspension of B737s fleet of Max Air, the Chairman of United Nigeria Airlines (UNA), Dr Obiora Okonkwo has urged the Nigerian Civil Aviation Authority (NCAA) to conduct an audit of all aviation fuel suppliers in the country.

"I would expect that NCAA should do a more acceptable audit on the fuel suppliers. We have been calling for this audit before now."

"All those supplying fuel to airlines should be properly audited," he added in an interview with aviation journalists.

He commended NCAA's decision to take such action, stating that it can only take a vigilant regulator to identify such situation and take action appropri-

He equally said Max Air had nothing to worry about since what happened could have happened to any airline. "It is expected of Max Air to give the answers to questions of NCAA."

On the federal government's intentions to provide cash palliatives to ameliorate effects of fuel subsidy removal, Obiora advised government that rather than give away cash handouts that may not solve the prevailing economic problems, government should invest in the aviation sector and strengthen the economy.

He said injecting capital in

form of palliatives into the aviation industry if given to those who may be qualified will create employment, increase revenue generation for airlines, bring about forex exchange and add to the Gross Domestic Product

Delivering his opening remarks at an all markets conference organized by Ndigboamaka Progressive Markets Association, Obiora said "there is more to gain from a United Nigeria, which incidentally is the name of the airline I established a few years ago. We must keep working to unite Nigerians with their visions, their aspirations, their neighbours and other societies for the good of our great country. Nigeria must be united; but Nigeria also must be a just and inclusive society.



NPA remits N55.7bn from N191.3bn raked in 6 months

he Nigerian Ports Authority (NPA) has generated N191.4 billion in revenue in the first half of 2023 and remitted N55.7 billion to the Consolidated Revenue Fund (CRF), its Managing Director, Mr Mohammed Bello-Koko, stated this in half year report on Tuesday in Lagos.

Bello-Koko said that given the existential economic headwinds both at the micro and macro levels, the operational statistics for the first six months were reassuring.

He said that the data catalysed the commendable remittances to the CRF of the Federal Government.

"Within the context of current global economic upheavals which have affected trade volumes in all climes, our current growth trajectory is encouraging. This gives us confidence to project a revenue growth of over N500 billion with a concomitant increase in remittance to the CRF by end-of-year 2023, given that shipping activities peak around the second half of the year.

"The smart policy thrust of the new administration which is already throwing up new vistas of growth further lends credence to the feasibility of our projections and gives fillip to our organisational initiatives," he said.

Bello-Koko said the operationalisation of Lekki Deep Seaport, expected restoration of the service boat management contract, digital-



isation and intensified tightening of collections mechanisms buoys their confidence to exceed the revenue projections.

'The authority has completed operations on a total number of 1851 vessels for the 1st half of 2023 with a combined Gross Registered Tonnage (GRT) of 57,870,083.

"Cargo throughput for the period under review stood at 33,895,784 metric tonnes, whilst container traffic was 707,985 TEUs (Twenty-foot Equivalent Units).

"A key indicator of port efficiency which is the average turnaround-time (TAT) of vessels, stood at 5.16 days.

"This is an improvement and we have put measures in place to surpass in the second half of 2023," he said. Bello-Koko said that the authority was poised to transform its projections to actualities.

He said the NPA would focus on finalising financing arrangements for port rehabilitation drive, the conclusion of all digitalisation geared toward improvement of efficiency during the second half of the year.

Court clears coast for prosecution of Court okays Ododo as APC guber suspended Adamawa REC

he Federal High Court sitting in Abuja yesterday cleared the coast for prosecution of Adamawa state suspended Resident Electoral Commissioner (REC), Hudu Yunusa Ari.

Justice Donatus Okorowo declined to extend his earlier order of July 10 that had barred, temporarily, the Independent National Electoral Commission (INEC), Inspector General of Police (IGP) and the Attorney General of the Federation (AGF) from prosecuting Adamawa state Resident Electoral Commissioner (REC), Hudu Yunusa Ari.

The court had issued the interim order stopping the prosecution of the suspended Ari pending the hearing and determination of a motion filed by Senator Aishatu Dahiru, also known as Binani.

INEC is seeking the prosecution of the suspended REC for usurpation of the function of Returning Officer by declaring the governorship candidate of the All-Progressives Congress (APC), Senator Binani, as winner of the Adamawa state governorship election on April 15, 2023, when the collation of results was not completed.

When the matter came up yesterday, INEC's counsel, Mr. Rotimi Jacobs (SAN) told the court that the applicant had not served the defendants with the July 10 order of the court.Jacobs also told the court that the defendants have not been served with the originating



summons filed by Binani.

He told the court that the life span of the interim order elapsed on July 18, but counsel to Binani, Michael Aondoaka (SAN) argued that the interim order has not elapsed as the defendants have not shown cause as directed by the court.

According to Aondoaka, counsel to INEC cannot say he was not served with the processes of the court as he had joined issues in the

Justice Okorowo, however, adjourned till Monday, July 24 for hearing in the originating summons served on the defendants in court yesterday.

After voting ended, the collation of results began at the state collation centre, but the exercise was suspended after results from 10 LGAs were announced.

However, Hudu Yunusa-Ari, the state's Resident Electoral Commissioner, declared Senator Binani winner before the collation resumed on April 16.

Yunusa-Ari made the declaration when outstanding results were yet to be announced. INEC subsequently described his action as illegal, saying it is null and void, suspended him and got set to prosecute him for electoral mal-

ustice Obiora Egwuatu of a Federal High Court in Abuja yesterday held that Mr Ahmed Ododo is legally qualified as flag bearer of the All-Progressives Congress (APC) in the forthcoming governorship election in Kogi State.

Justice Egwuatu made the decision while delivering judgment in a suit seeking his disqualification over alleged breach of the electoral laws.

Ododo had won the APC primary election of April 14, 2023, which some of the contestants disputed and claimed that he was not qualified to have contested the primary in the first place.

Dissatisfied over his emergence, an aspirant of the APC, Mr Abubakar Achimugu, had approached the Federal High Court, Abuja, asking that Ododo be disqualified from contesting the November 11 governorship election on grounds that he did not resign his employment with the Kogi State public service 30 days before contesting the governorship

Delivering judgment in the suit yesterday, Justice Egwuatu held that contrary to Achimuggu's claim, evidence showed that Ododo resigned his appointment more than 30 days before participating in the APC primary.

According to Justice Egwuatu, exhibits tendered by the defendants showed that while Ododo's resignation letter was received by the Office of the Kogi State Governor on March 8, 2023, that of the 3rd defendant, Mr Salami Deedat, was received on March 9.

The court, while noting that an employee or appointee's resignation letter comes into effect the moment the notice is received, held that the employee would not be held responsible if the employer neglected to act on it either by continuing with the payment of salary.

"Satisfied that they resigned their appointment on March 8 and 9, more than 30 days before the April 14 primary...the suit is bereft of any merit and accordingly dismissed," the court held.

he Federal government has been called upon to reverse the relocation of aviation agencies to Lagos in the interest of the industry and the country's economy.

The general Secretary of Association of Nigeria Aviation Professionals (ANAP), Comrade Abdurasaq Saidu, who made this call in an exclusive interview with Daily Times aviation revealed, that agencies relocation to Abuja has done the aviation industry no good.

Saidu explained, that since the movement, the security apparatus of agencies in Lagos especially at the MMIA has collapsed adding, that the security system has been distablised.

He said, it was a wrong policy of the former administration and urged president Bola Tinubu to order agencies back to Lagos as it was not in the act establishing these agencies neither in the laws of

the country.

"The movement of all aviation agencies to Abuja weakened, distabilised the security, efficiency and effectiveness at the gateway airport (MMIA) to the country".

He also noted that experienced staff, operational vehicles and other operational requirements were distabilised.

Saidu explained, that loss of revenue in the sector has remained as one of the dangers of the relocation due to what he termed as conspiracy within and outside the service providers and the airlines in terms of payment of required revenue adding that the Federal government was losing heavily from expected revenue.

On the runway lightings theft, comrade Saidu said it might have been as a result of the closure of the runway to give room for repairs that was not done as scheduled and accelerated as miscreant found their way there.

Saidu said workers within the system were being frustrated as a result of the economic crunch without approved conclusion of service for workers as all their entitlement were not paid as at when due.

He blamed the obnoxious policy of the former administration, saying that the policy was uncalled for as it was used to perpetuate evil in terms of employment, contracts and exhorting money from parastatals for overseas trips.

He called for appointment of experienced general manager that have served for almost 15 years in aviation agencies to become directors than bring people without knowledge to head directorates saying it will ensure efficiency.

Saidu called on all directors appointed from outside the aviation industry to resign their appointments and allow the new managing directors to work especially that of FAAN.

While one of the graduands obtained Commercial Pilot Licence (CPL), Instrument Rating and Multi-Engine, the remaining three bagged Private Pilot Licence (PPL).

This was coming about a month after five newly graduated pilots were decorated by the college, increasing the number of pilots produced from March 2022 till date to 31.

NCAA admits flaw in data on delays, cancellations, others

he Director General, Nigeria Civil Aviation (NCAA), Captain Musa Nuhu says there were flaws in the released data on delays, cancellations, baggage losses and other passenger and traffic figures of domestic airlines

Just as he declared that reasons for delays will be categorized to help airlines improve.

Airline Operators have accused the NCAA on irregularities on recently released figures on delays and cancellations at the Aviation Safety Round Table Initiative (ASRTI) Brunch Business Meeting held in Lagos

AON said it was unfair to blamebairlines for poor performances because the CAA only provided data without breakdowns.

They described it as unfair

and said there were other multiple factors beyond airlines that cause cancellations which should be highlighted instead of making it look like the airlines' fault entirely.

Captain Nuhu who agreed with this position while speaking to reporters via zoom said, there were many other factors that caused delays and highlighting them is also a means of strengthening the industry to do a better job at improving on

He said, "When you say delays and there are many reasons for delays it is only fair and proper for everybody to give reasons for delays. What percentage of delays was caused by infrastructure? What amount of delay was caused by weather? What delays were caused by the airlines themselves, I think this is fair enough.

"I think the different reasons for the delays are important and we will take that into consideration for fairness to everybody because if you just say delay you might create a wrong Impression that the airlines are responsible for 100% of the delays.

"I want to say delays are a global phenomenon but we want to minimize the number of delays that happen. If you know the reasons, if you categorize the reasons then you can see where actions can be taken or changes can be made or measures can be put in place to minimize such delays.

"So yes in fairness to them, I do agree with them that the report could have carried different reasons for the delays. So going forward we've listened to them and we will try to include that in our reports."

Brighton reject £70m Chelsea bid for Caicedo



righton have rejected a second Chelsea bid, believed to be about £70m, for midfielder Moises Caicedo.

The Ecuador international asked to leave Brighton in January amid interest from Arsenal.

Brighton refused and subsequently

signed a new contract in March that runs to 2027.

However, he remains of huge interest to a number of Premier League clubs, with Chelsea most keen to sign the 21-year-old.

Chelsea are scheduled to meet Brighton in the opening game of the Premier League's six-team pre-season tournament in Philadelphia on Saturday.

Caicedo will travel to the US direct from Ecuador having been given extra time off, while Brighton's squad will fly out on Tuesday.

He joined Brighton from Ecuadorian side Independiente del Valle for a reported £4.5m in February 2021 but did not play that season.

Caicedo spent the first half of the 2021-22 season on loan with Beerschot in Belgium before Brighton recalled him in January 2022.

He made his Premier League debut in April 2022 and has played 53 times for Brighton, scoring twice.

Edwin van der Sar out of intensive care



ormer Netherlands goalkeeper Edwin van der Sar has been moved out of intensive care following a bleed on the brain.

The ex-Manchester United and Ajax player, 52, was taken to hospital while on holiday in Croatia before being transferred to a Dutch hospital.

"I'm happy to share that 'm no longer in the intensive care unit," Van der Sar said in a statement on his

"However, I'm still in hospital. I hope to go home next week and take the next step in my recovery."

There was an outpouring of goodwill messages to Van der Sar after news of his condition broke on 7 July and he expressed his gratitude in the latest update.

"We want to thank everyone for all the great and supportive messages," he

Van der Sar, who won 130 caps for his country, resigned from his role as Ajax chief executive in May after the side finished third in the Dutch league and failed to qualify for the Champions League for the first time since 2009.

He retired from playing after leaving United in 2011 before joining the Ajax board in 2012, and becoming the club's chief executive in 2016.

Van der Sar made 266 appearances for the Red Devils and helped them to win four Premier League titles and the 2008 Champions League. He also played for Fulham and Juventus.

Manchester United agree deal for Inter Milan goalkeeper Onana

anchester United have agreed a £47.2m (55m euros) deal for Inter Milan goalkeeper Andre Onana.

The Old Trafford club will pay £43.8m up front for the Cameroon player, with an additional £3.4m in add-ons.

United hope he will be able to join them on their upcoming tour of the United States - although they have to arrange a visa for the 27-year-old.

Manager Erik ten Hag moved for the keeper at the end of the season after previously working with him at Ajax.

He will join on a five-year contract, with the option for

Ten Hag feels Onana can be a significant addition to United's squad and his pursuit of a new goalkeeper prompted David de Gea to turn down a new contract

De Gea was United's first-choice keeper for the past 12 years, making 545 appearances after joining the club under Sir Alex Fer-

The Spaniard's 190 clean sheets are a club record for a goalkeeper.

Onana spent seven and a half years at Ajax before moving to Inter in July 2022 on a free transfer.

He kept eight clean sheets in 24 Serie A games as Inter finished third and no team scored past him in 13 of their matches in the Champions League last sea-



keeper in the competition.

He played against Manchester City in the Champions League final in June as Inter lost 1-0.

The keeper retired from international football in December after falling out with Cameroon boss Rigobert Song at the World Cup.

Onana will be United's second signing of the summer, after the arrival of midfielder Mason Mount from Chelsea for an initial £55m, and attention now turns to their third recruitment priority, a central striker.

United received no encouragement during initial discussions around signing Tottenham's Harry Kane and Atalanta's Denmark striker Rasmus Hojlund is high on their list of alter-

Hojlund joined Atalanta in August 2022 and scored 10 goals in 34 appearances last season. He made his international debut in September 2022 and has six goals in six games all in qualifying for Euro 2024.

However, while personal terms are not expected to be a problem in completing a deal, there has been no agreement with the Serie A club over a fee. Atalanta are understood to want 70m euros (£60.2m) for the 20-year-old.

Having committed more than £100m on their two signings so far, and having been fined by Uefa for breaking Financial Fair Play rules last week, United want to stick to their budget.

It means other options, including Eintracht Frankfurt's highly-rated France striker Randal Kolo Muani, 24, are coming into play.

Kolo Muani has attracted the interest of Paris St-Germain amid ongoing uncertainty over the future of Kylian Mbappe whilst Bayern Munich may turn to the 24-year-old if they also fail in their attempt to lure Kane to Germany.

Rashford signs new contract with Man Utd until 2028

ngland forward Marcus Rashford has signed a new deal to stay at Manchester United until 2028 worth £325,000-a-week

The 25-year-old had been in talks with United for a considerable period, with his previous contract due to expire in 2024.

The striker enjoyed a resurgence under new manager Erik ten Hag last season, scoring 30 goals in 56 games.

Since his debut in 2016 against Midtjylland, Rashford has hit 123 goals in 359 games for his boyhood

Rashford said: "I joined Manchester United as a seven-year-old boy with a dream. That same passion, pride, and determination to succeed still drives me every time I have the honour of wearing the shirt.

"I've already had some amazing experiences at this incredible club, but there is still a lot more to achieve and I remain relentlessly

determined to win more trophies in the years ahead."

Rashford is believed to have dismissed more lucrative offers from within the Premier League and abroad to stay at Old Trafford, committing through to 30 June 2028 and backing Ten Hag to deliver more success.

He said: "I can assure you that I will give everything to help the team reach the level we are capable of, and I can feel the same determination around the dressing room. I couldn't be more excited for the future under this manager."

Rashford was one of three England players to suffer racist abuse after missing a penalty in the Euro 2020 final defeat by Italy.

He had shoulder surgery in August 2021, saying he must "listen to his body", before struggling for form and scoring only five times during a campaign that saw Ole Gunnar Solskjaer succeeded by interim boss Ralf Rangnick.

2026 Commonwealth Games in doubt after Victoria cancels hosting plans

2026 Commonwealth Games are in doubt after the Australian state of Victoria cancelled its plans to host due to budget blowouts.

The Commonwealth Games Federation (CGF) struggled to find a host before Victoria volunteered in April 2022.

But the premier said the projected cost had now tripled and become "well and truly too much" for the state to bear.

The CGF called the decision "hugely disappointing" and said it is "committed to finding a solution".

The Commonwealth Games are a multi-sport tournament that take place every four years. They have only ever been cancelled during World War Two.

To be eligible to participate in the games, competitors must be from one of the Commonwealth's 56 members. Most of the countries in the Commonwealth were once part of the British Empire.

Victorian Premier Daniel Andrews said on Tuesday that his state had been



"happy to help out" when approached to host last year, but "not at any price".

Downing Street said the cancellation was "disappointing" for fans and athletes.

Prime Minister Rishi Sunak's spokesman said the UK government hoped "a viable solution" could be found by the Australian authorities and the CGF.

He rejected a claim the move was a sign of the decline of the Commonwealth as a whole, suggesting the King's coronation showed "the strength of the Commonwealth and commitment of countries to it".

Organisers had originally estimated the event - hosted across cities including Geelong, Bendigo and Ballarat - would cost A\$2.6bn (£1.4bn; \$1.8bn) and the state government had billed it as a boost for the regions.

But now the 12-day tournament was expected to cost more than A\$6 billion (£3.13bn; \$4.09bn), Mr Andrews said, adding that the new figure was "more than twice the estimated economic benefit" it would bring to Victoria.

"I've made a lot of difficult calls, a lot of very difficult decisions in this job. This is not one of them," he told a press conference.

"That is all cost and no benefit."

The government will still complete the stadium upgrades it had promised ahead of the games, while using the money it is now saving on housing and tourism initiatives.

Abia denies sacking Finidi as Enyimba manager

Fuel subsidy removal: Making a case for existing modular refineries

he removal of fuel subsidy seems to have become a settled matter following years of contemplations. The president, Bola Ahmed Tinubu, said during his inauguration speech that 'fuel subsidy is gone'.

That statement ended an age long subsidy regime which many believed was a scam and a heist of unquantifiable dimension. The crime perpetuated in the name of fuel subsidy created a quagmire in the oil & gas industry where more than half of the purportedly imported and subsidized petroleum products were stolen by corrupt industry players who cared less about the mostly poor and vulnerable citizens for whom subsidy was necessary and had impact.

While we are in the midst of the seeming confusion created by the removal, it is regrettable, however, that not a single culprit has been named, charged or punished owing to the corruption and stealing, the criminal malfeasance, by those in places of authority with the mandate to regulate the sector. Many of them, out of negligence or collusion, allowed the level of mismanagement that greeted the subsidy regime thereby throwing the entire country into avoidable crisis.

With a new era now upon us, what has become a matter of concern is supply and availability of petrol at price that will not be excruciating. The price of premium motor spirit (pms) has reached an all-time high in recent days since the announcement of removal of subsidy. This price change arising from the removal brought with it unprecedented hardship and pains on the ordinary people. Unfortunately, prior to this time, not the previous administration or the current administration demonstrated any concrete plans showing how the

government intended to ameliorate the impact of the removal. The planned palliatives and cash transfer of 8,000 naira to 12 million to poor household, which seem as an afterthought, has attracted a barrage of criticisms and skepticism. The reasons for such skepticisms are not farfetched given previous similar experiences in the past where government went to town to 'share money' with no evidence of impact on the lives of ordinary people or not enough proof that those who should benefit actually benefited.

From the stand point of ongoing debates, and beyond the questions of palliative, my very most sincere concern as with most Nigerians, is how the government can guarantee steady availability of pms and gradually reduce importation of same with the expected positive implications being the freeing up of the scare foreign exchange earning being used to import finished petrol products. The crude oil refineries owners association, CORAN, an association comprising businesses that have operating licenses for modular refineries have made the case that government can enable them to function better. They have made the point that, with their combined installed refining capacity, they can contribute to ensuring that petrol is readily available and can be accessed at even lower price in country.

There are 40 modular

refinery licenses issued, but as at this moment, only about four or five of such refineries are functional at very minimal scale. The general complain by the owners of these modular refineries is that the Nigeria National Petroleum Company (NNPC) has refused to provide them with enough crude oil to meet production demand. This calls for serious concern as I wonder the kind of a nation that we have. The Crude Oil Refineries Owner's association have in their recent public communications made the argument that refining crude oil in the modular refineries will be more cost-effective than exporting the crude abroad for refining and then shipping it back for sale as finished refined petroleum products with the attendant impact on foreign exchange and even on the landing cost with transportation taking a chunk of the pump price.

Also, they have made the point that local refining through the modular refineries will reduce incidences of oil theft and vandalism of pipelines as has been the case for several years because most of the modular refineries are located close to wellhead for crude

With the conventional refineries almost moribund and the Dangote refinery yet to come on stream fully, it will be sensible options for the government to quickly empower the modular refineries with the support that will enable them begin refining. This will entail giving

them access to enough crude oil to refine. This will also encourage them to acquire the needed technical support such as the reformer that s need to refine pms. It makes no sense for government to issue licenses for modular refineries and yet make it impossible for these refineries to function optimally.

It is the duty of government to ensure that Nigerians have a better and improved life. One of the ways to fulfill this obligation is to address the problems that have made it impossible for the modular refineries to perform. The operators have made the case that government should allow them to buy crude oil in naira instead of dollars since there is no basis to buy commodities with foreign currencies when the final product will be retailed in Nigeria and in naira. This is also very important taking into consideration the current scarcity of dollars due largely to dwindling government foreign exchange receipts. Other issues that have been put forward are levies placed on modular refineries with resultant increase in the cost of refined products.

All said, it has become imperative for the federal government, through the relevant agencies, to take urgent steps to support all the operational and installed modular refineries. There is no justification for a country that produces crude to discourage local refining of same. The attendant benefits to the economy will be enormous when the modular refineries are supported to operate optimally. The expected coming on stream of the Dangote refinery should not hinder needed investment in already built and installed modular refineries.
